## DISCLAIMER

This report provides a detailed overview and complete results of demographic representation across Canada Media Fund's (CMF) programs during the 2023-2024 period. The demographic information used in this report has been collected through [PERSONA-ID](#), the CMF's voluntary self-identification system launched in early 2022.

As stated in the summary version of this report, the 2023-2024 Demographic Report is part of the CMF's Analytics and Strategic Insights (ASI) mandate on data equity, which analyzes demographic data to produce data-driven insights that support the CMF's Equity, Diversity, Inclusion, and Accessibility (EDIA) objectives.

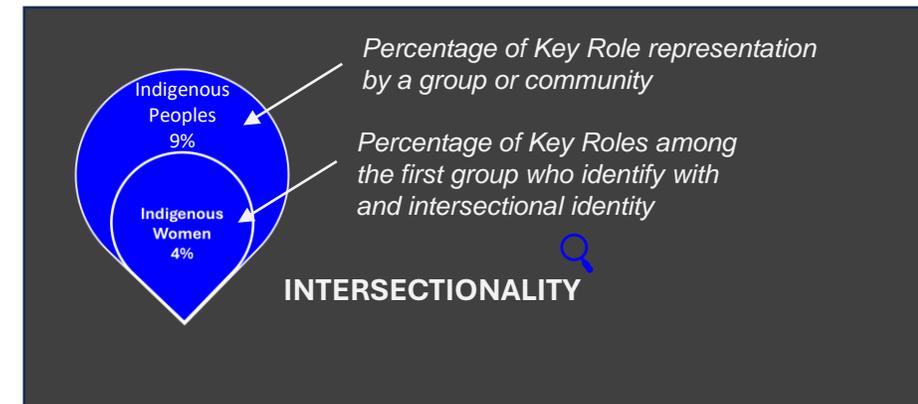

# 1. INTRODUCTION

# WHAT'S NEW WITH THIS REPORT

- **Key Roles and Ownership Combined:** This year, results for Key Roles and Ownership\* are presented together within each demographic category. In last year's report, these metrics were presented in separate sections.
- **Year-over-Year Comparisons:** With two years of data now available, this report includes comparisons of overall representation in Linear and Interactive programs between 2022-2023 and 2023-2024. However, sections dedicated to individual programs or program types focus exclusively on 2023-2024 results.
- **Genre-specific results:** For the first time, the overall results are broken down by genre, including Drama, Documentary, Children's and Youth, and Variety and Performing Arts, providing a deeper understanding of representation across these content categories.
- **Selective and Automatic Program Totals:** This year's report includes aggregate results for both selective and automatic programs, offering a clearer and more seamless comparison of demographic representation across these two program types.
- **Narrative Positioning:** Preliminary results are presented for the new "Narrative Positioning" section introduced in 2023-2024. Applicants were asked if their projects "include or reflect storylines, main characters, or subject matter related to one or more of the following" Indigenous or Equity-Seeking communities, which include Indigenous Peoples, Racialized Communities, Persons with Disabilities, 2SLGBTQ+, Women, and Official Language Minority Communities, and Regional Communities.

- **Sector Development:** For the first time, the report includes data from the Sector Development Support Program, showing aggregate demographic representation among funded applications' project leads and board members
- **Intersectionality:** Unlike the previous report, this year's findings on intersectionality are integrated into the graphics alongside other results, rather than presented as a separate section. Intersectionality refers to the complex ways in which an individual or group may experience or identify with overlapping social categories, resulting in both advantages and disadvantages. # READING CONSIDERATIONS

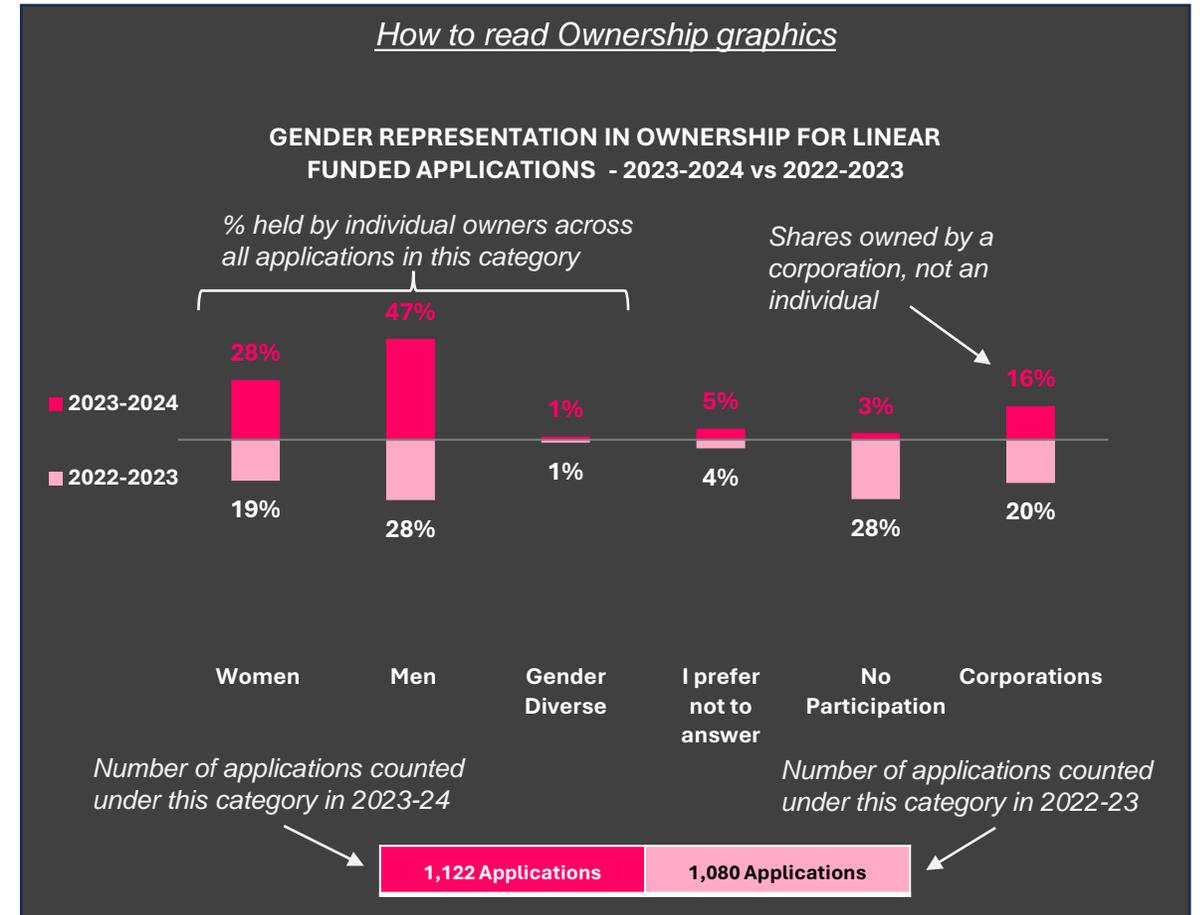
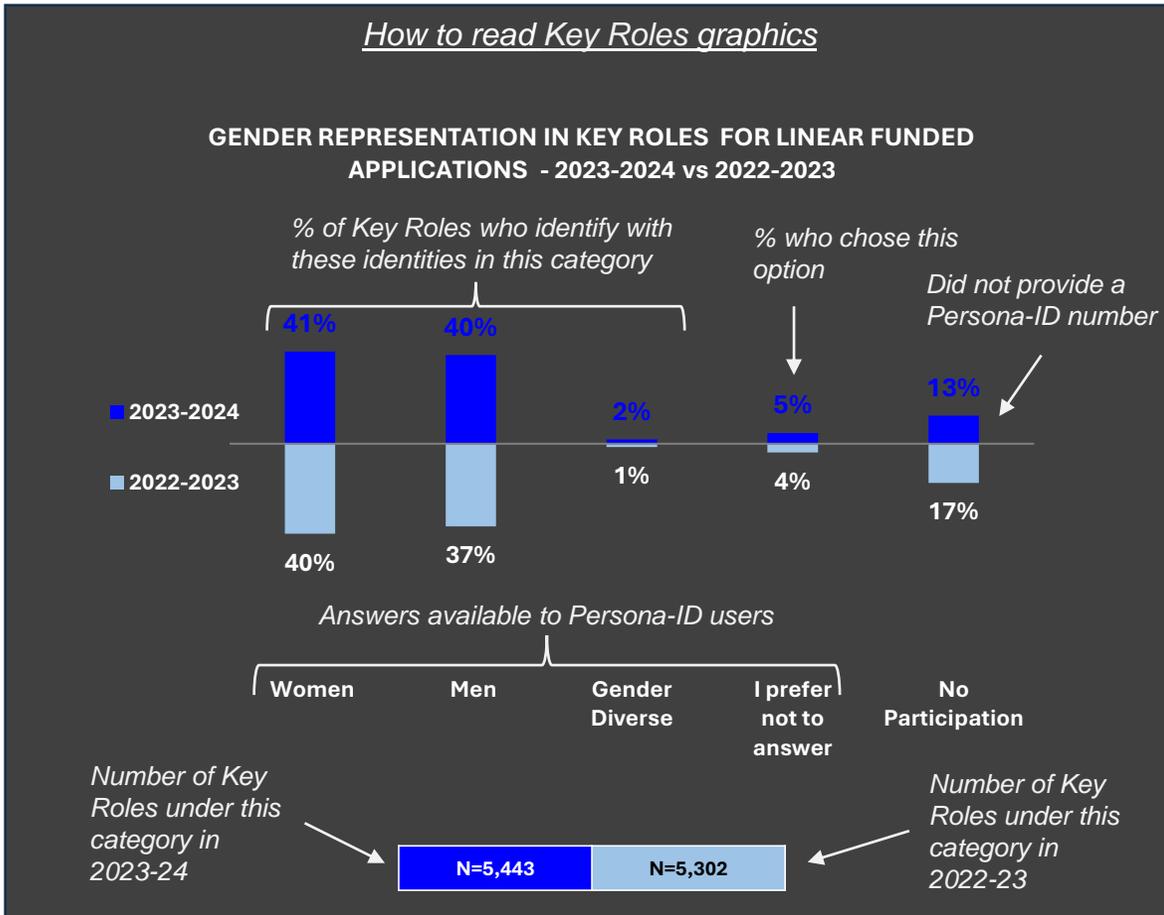
Important considerations to keep in mind when reading this report:

- ✦ **Dynamic Data:** The demographic and per-program funding results presented here are dynamic and may change over time. This can occur due to unexpected changes in project status, funding adjustments, or shifts in project composition after applications are submitted or funding is allocated within a fiscal year.
- ✦ **Scope of the Report:** This report focuses on specific CMF programs and does not include initiatives like National Partnerships, International Incentives, SEEK MORE, or event partnerships. For a broader overview, please refer to the [2023-2024 Annual Report](#) and additional resources on the [CMF website](#).
- ✦ **Content Comparison:** Linear and interactive content have different company ownership, Key Roles, and selection criteria. Direct comparisons between the two content types may not provide meaningful insights.
- ✦ **Key Roles Representation:** The "Key Roles" metric does not represent the unique count of industry professionals, as one individual may hold multiple roles within the same application or across multiple applications. For example, an Indigenous creator serving as both Writer and Director on a single project would statistically be counted as two Key Roles held by Indigenous people.
- ✦ **Ownership Representation:** The "Ownership" metric reflects the proportion of shares held by individuals or groups with shared identities, rather than the number of individual shareholders. For instance, if a single Racialized shareholder holds 51% of an applicant company's shares, while the remaining 49% are held by multiple non-Racialized shareholders, the applicant company is still considered to have 51% ownership held by members of Racialized Communities\*.
- ✦ **Calculation of Percentages:** All percentages for Key Roles and Ownership are calculated based on the total number of respondents, including those who did not provide a PERSONA-ID number at application. Responses of "I prefer not to answer" are counted as a choice by the respondent and are distinct from No Participation.
- ✦ **Program Requirements and Incentives:** Many CMF programs include incentives or requirements for which individuals of specific identities must self-identify through PERSONA-ID to participate in. This may influence response levels in certain programs and contribute to the higher or lower representation of some communities in this report.

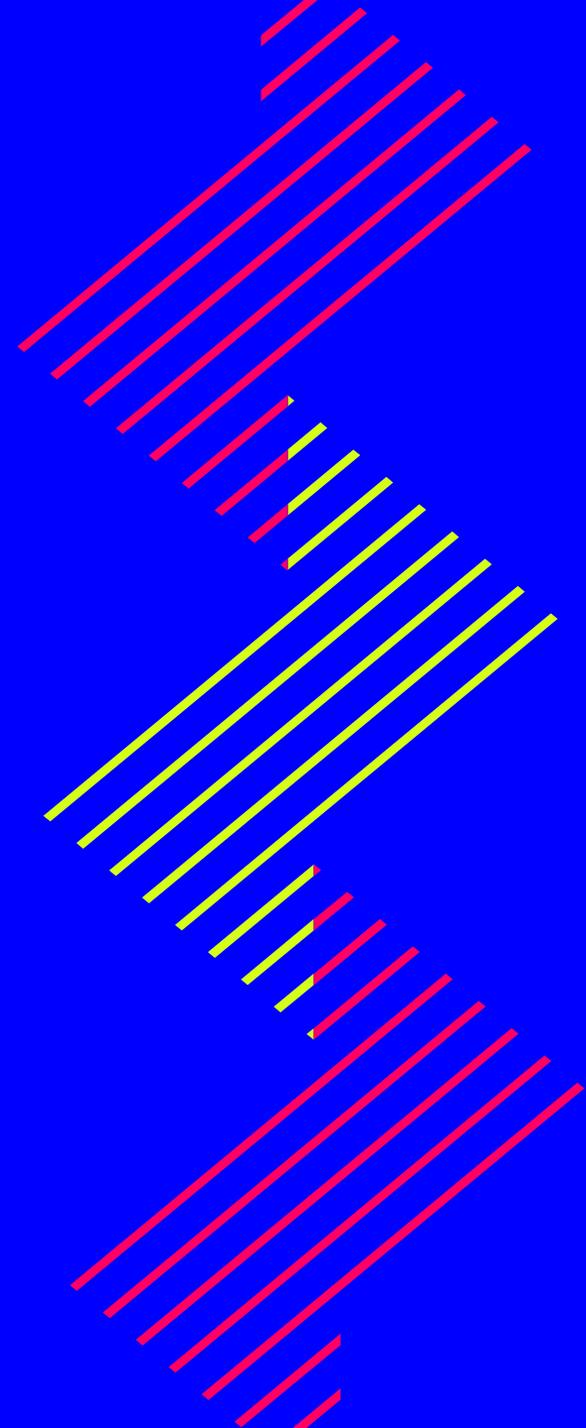

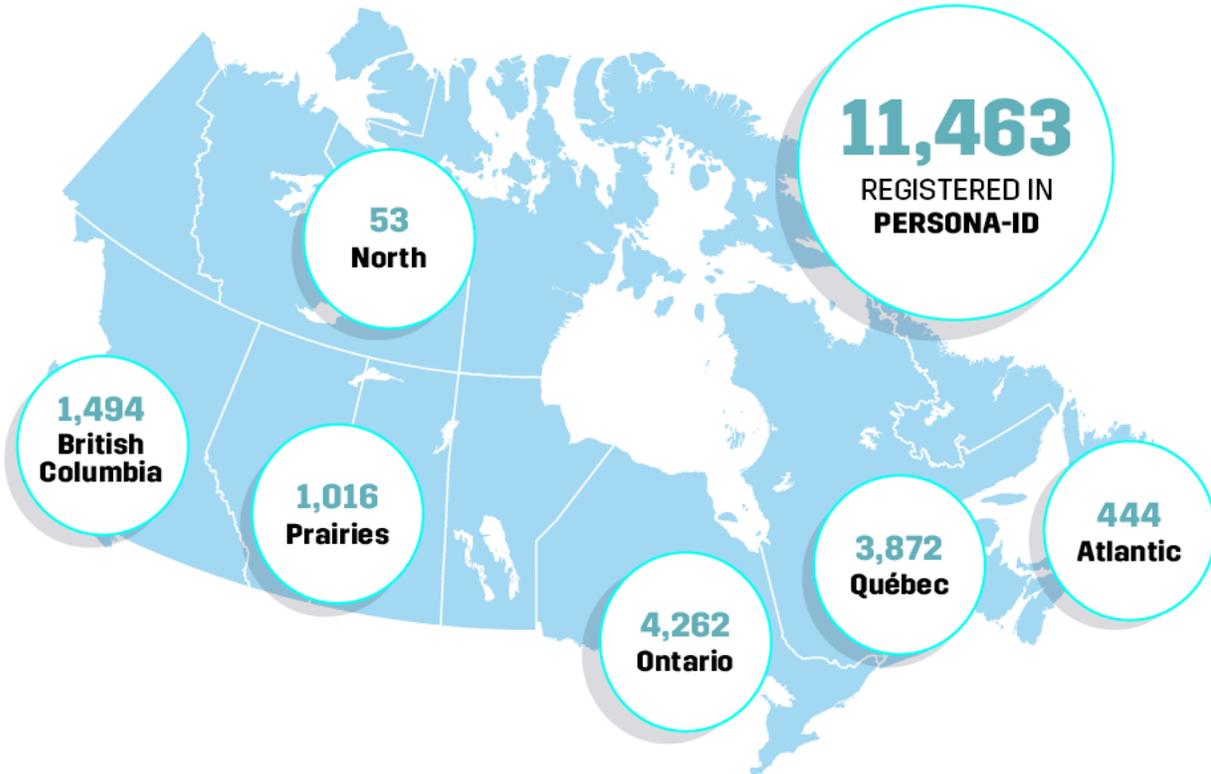

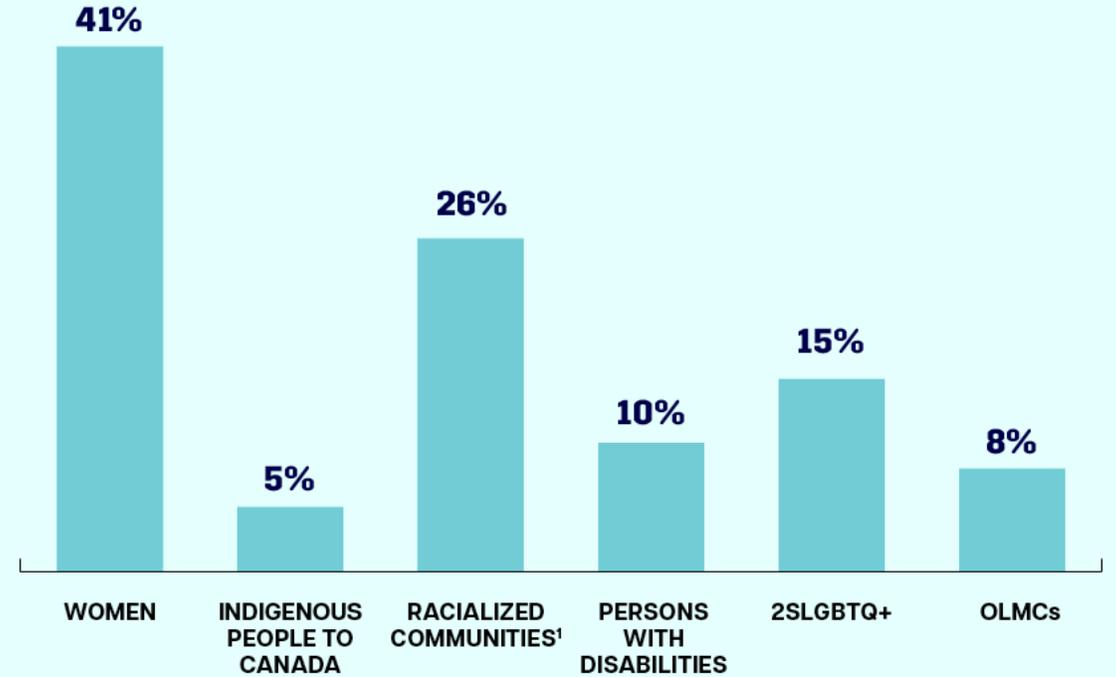
# PERSONA-ID REGISTRY

As of April 11, 2024, 11,463 users were registered in **PERSONA-ID**, the Canada Media Fund's voluntary self-identification platform. This registry includes a wide range of industry professionals involved both in linear and interactive content, beyond the Key Roles and Shareholders focused on in this report. It includes performers, music composers, editors, designers, programmers, and many more. The registry also includes project leads and board members of organizations applying to the Sector Development Support program.

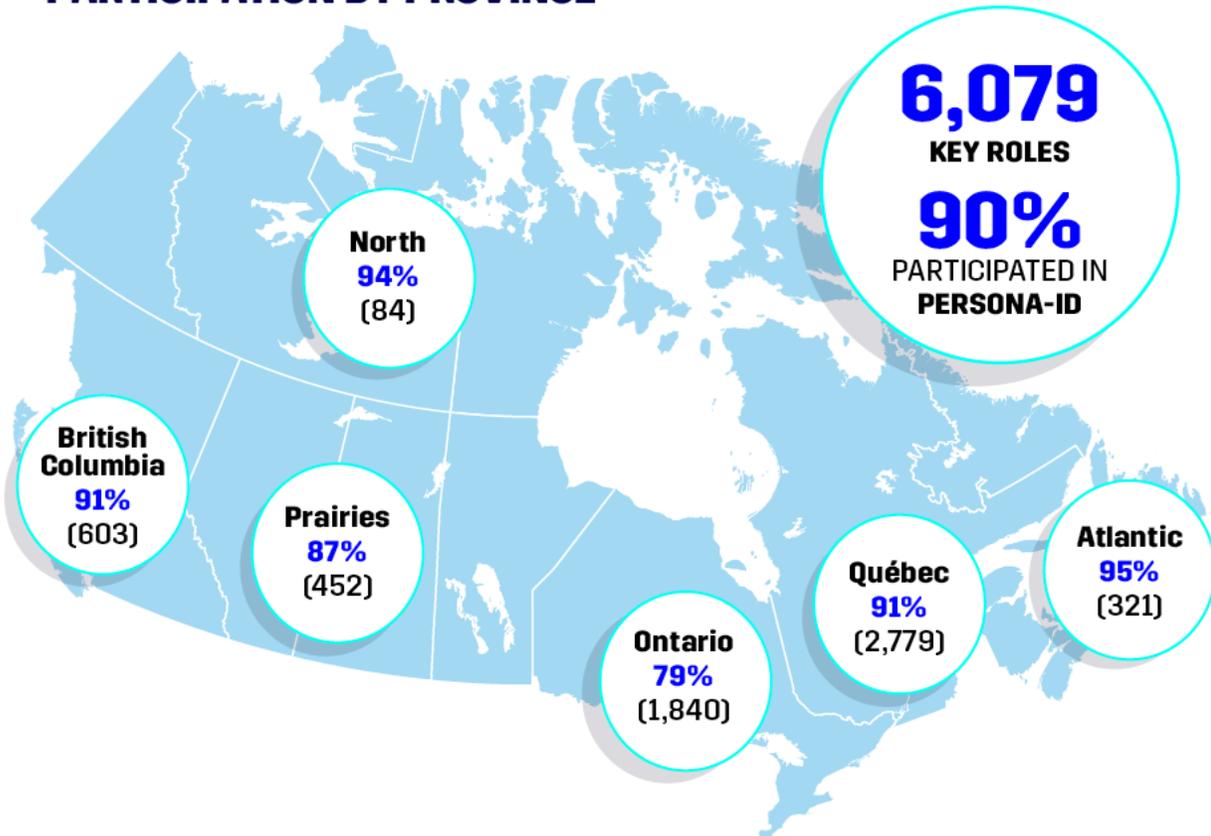

# PARTICIPATION IN PERSONA-ID BY KEY ROLES

Among Key Roles, PERSONA-ID participation increased overall, from 83% in 2022-2023 to 89% in 2023-2024 in linear content, and from 83% to 92% in Interactive digital media (IDM). Notably, participation in British Columbia increased by +10 percentage points, and by +8 points in Ontario. English-language productions in linear increased by +8 points.

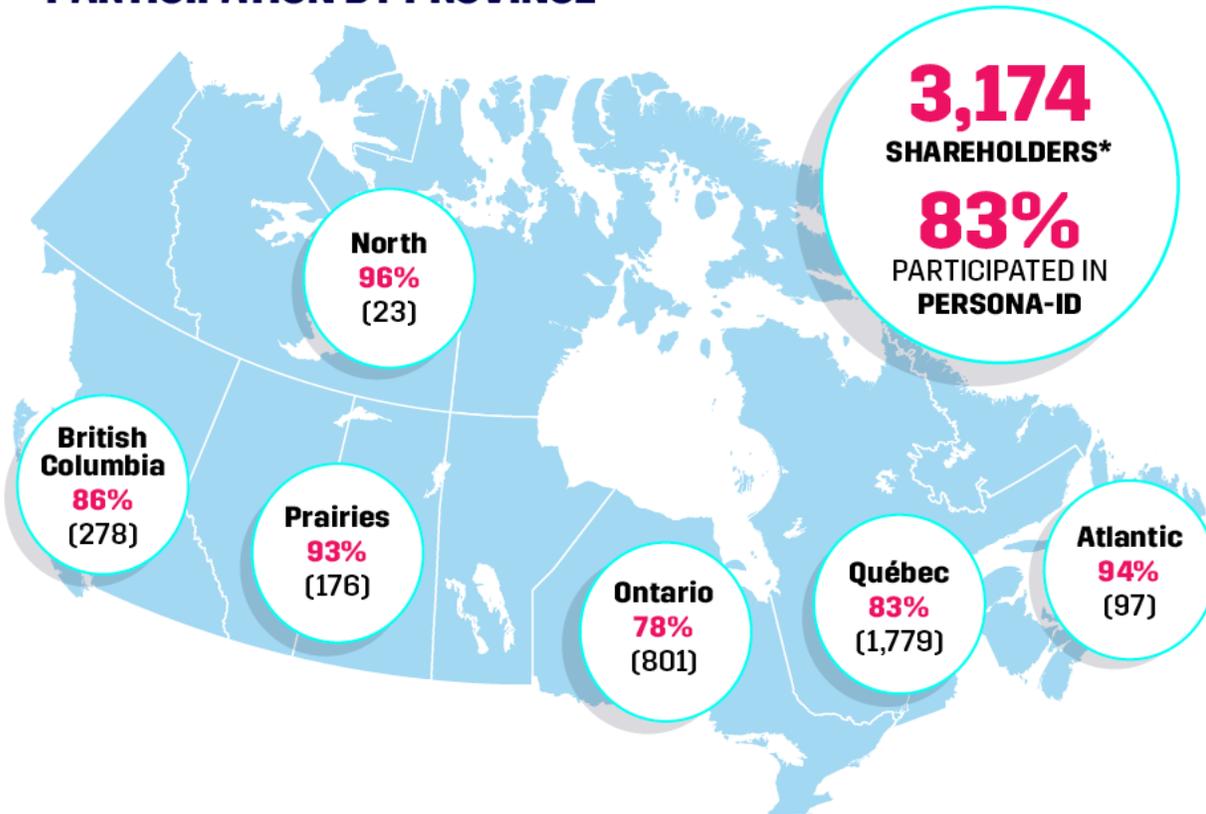
## PARTICIPATION BY LANGUAGE OF PRODUCTION IN LINEAR CONTENT - PRODUCTION



# PARTICIPATION IN PERSONA-ID BY SHAREHOLDERS (OWNERSHIP)

In 2023-2024, **Shareholder participation in PERSONA-ID increased significantly over the previous year**, from 66% to 82% in linear content and from 68% to 92% in interactive digital media (IDM). This increase was most pronounced in English-language production and in British Columbia, where it rose by +24 percentage points in each. As noted above, this increase in participation provides more accuracy but limits the ability to compare year-over-year results.

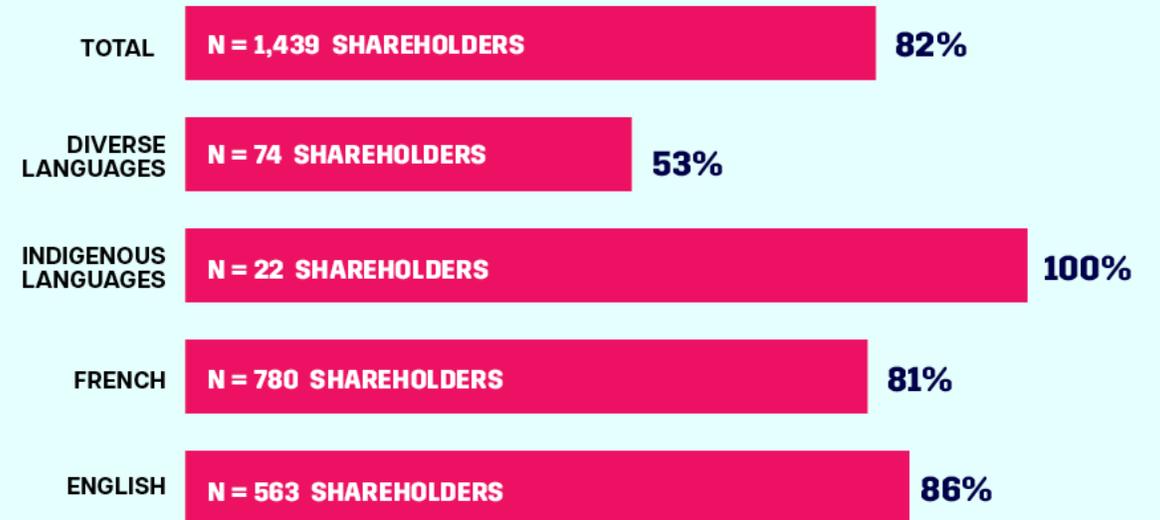

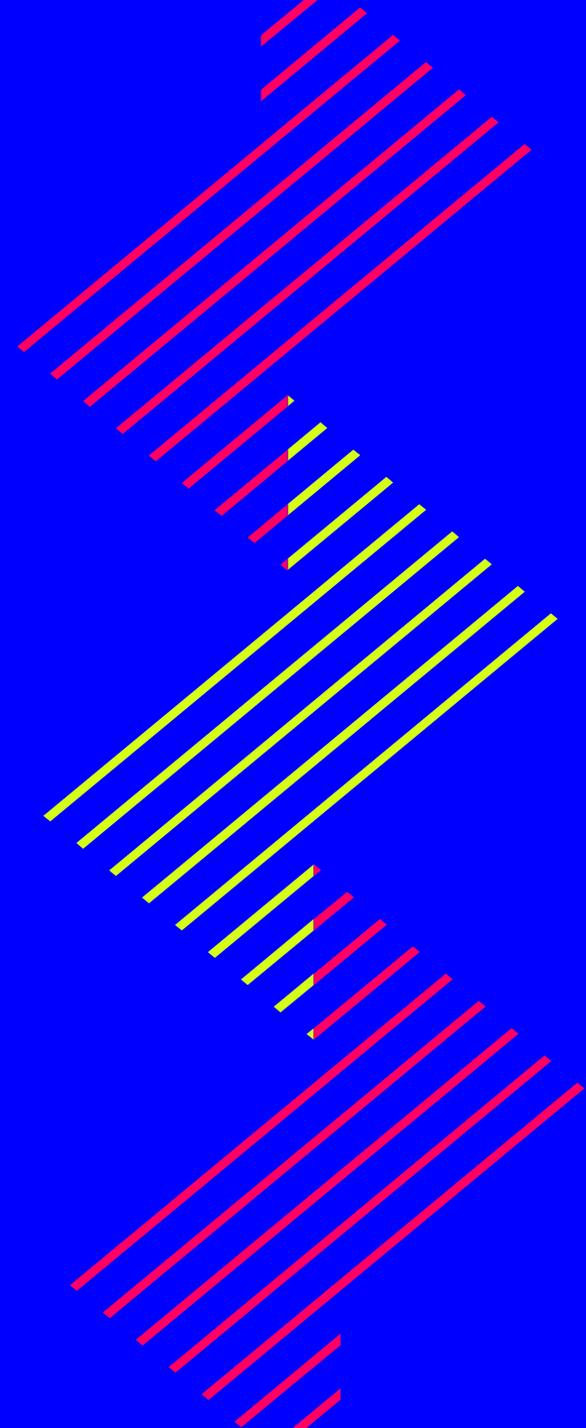
## PARTICIPATION BY LANGUAGE OF PRODUCTION IN LINEAR CONTENT - PRODUCTION

# REPRESENTATION IN LINEAR CONTENT - OVERVIEW

This section reports on the overall demographic and social identity of Key Roles and Ownership from all funded Linear Content applications in 2023-2024, as disclosed through PERSONA-ID. It is important to note that until April 2024, all linear programs fell under CMF's "Convergent Stream" category, while all interactive digital media (IDM) programs fell under the "Experimental Stream" category. Since then, all programs have been reorganized on the CMF's website into the following three new pillars which reflect stages of production and funding objectives: "Ideation, Creation and Industry."

However, given that the data presented in this report reflects results from 2023-2024, the information will mostly be divided into linear and IDM.

The linear programs support content for distribution on television and television-related platforms in four genres: Drama, Documentary, Children's & Youth, and Variety & Performing Arts, and often in three stages of production: Predevelopment, Development and Production.

In this report, results for "Representation in Linear Content" are presented in three sections: Overall, selective Programs, and automatic Programs.

- **Overall** reports on the results for all linear content combined following the PERSONA-ID demographic categories, broken down by language of production, specific Key Roles, and genres.
- **Selective Programs** presents the combined results for all programs which include an evaluation process, carried out by an internal or external jury or committee. Then, the report focuses on results for a few key selective programs: the Indigenous Program, the Pilot Program for Racialized Communities (now called Program for Racialized Communities) and the Pilot Program for Digital Creators.
- **Automatic Programs** include all linear content programs that can be accessed on a first-come, first-served basis and through the Envelope Programs. These results are presented first combining all programs' results, then focuses on the following programs; the Performance Envelope (now called the Broadcasters Envelope), the Development Envelope, the Predevelopment and Development sections under the Indigenous Program, and the Pilot Program for Racialized Communities.

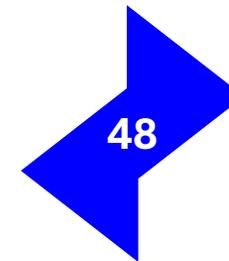

# NARRATIVE POSITIONING IN LINEAR CONTENT

As of April 2023, the CMF’s application process collects information to measure how much of the content “includes or reflects storylines, main characters or subject matter” related to Indigenous and Equity-Seeking Communities\*. This information allows the CMF to track the progress of its [Narrative Positioning Policy](#) and provides insights into the type of content funded through its programs. It is important to note that in 2023-24, the question on the application referred to “Sovereignty and Equity-Seeking Communities”, however the report uses the term “Indigenous and Equity-Seeking Communities” to refer to these communities.

**While 62% of overall projects featured at least one Indigenous or Equity-Seeking storyline, nearly 60% of French language productions did not feature these storylines.**

**Significantly, 82% of English language productions with larger budgets (over \$10M) included at least one Indigenous and Equity-Seeking storyline, whereas 46% of smaller budget French language productions (under \$1M) featured such storylines.**

# NARRATIVE POSITIONING IN LINEAR CONTENT

Key Roles held by members of Indigenous and Equity-Seeking Communities have higher representation when the storylines, main characters, or subject matter are related to their own community.

Racialized Communities and Women were represented most among Indigenous and Equity-Seeking Community storyline narratives in both French and English.

At 55%, Key Roles occupied by OLMCs show a greater presence in projects addressing their stories.

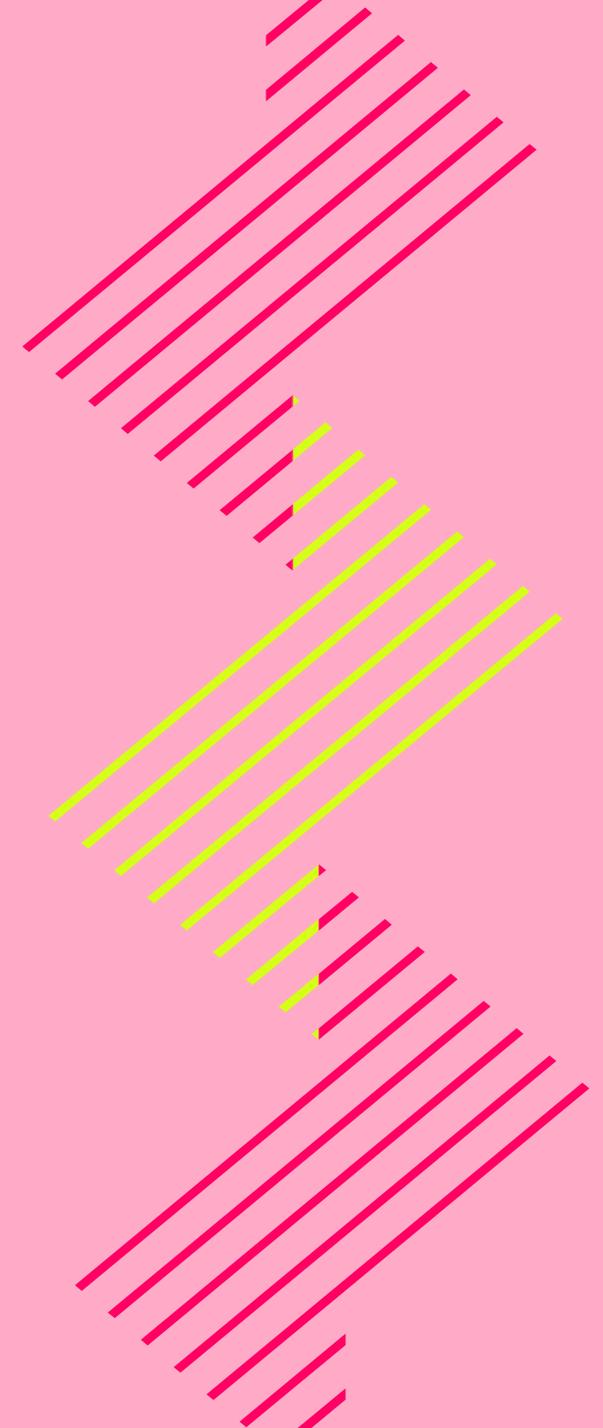

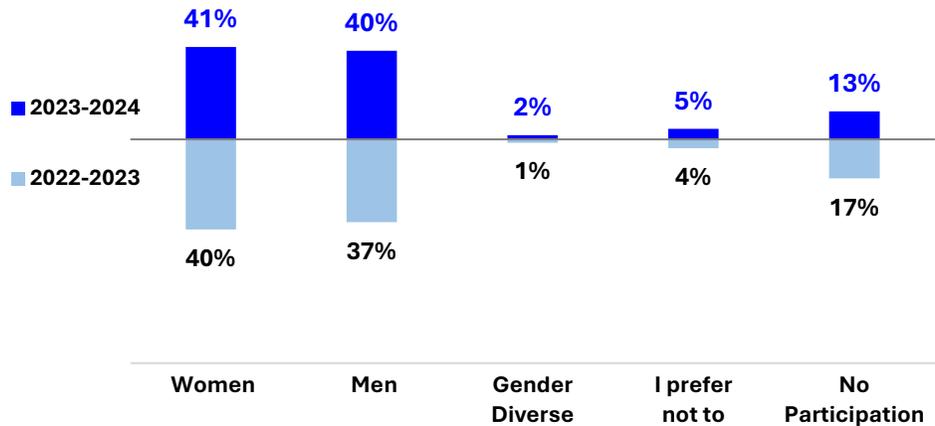

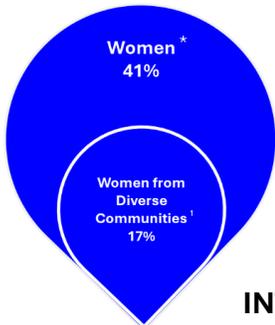
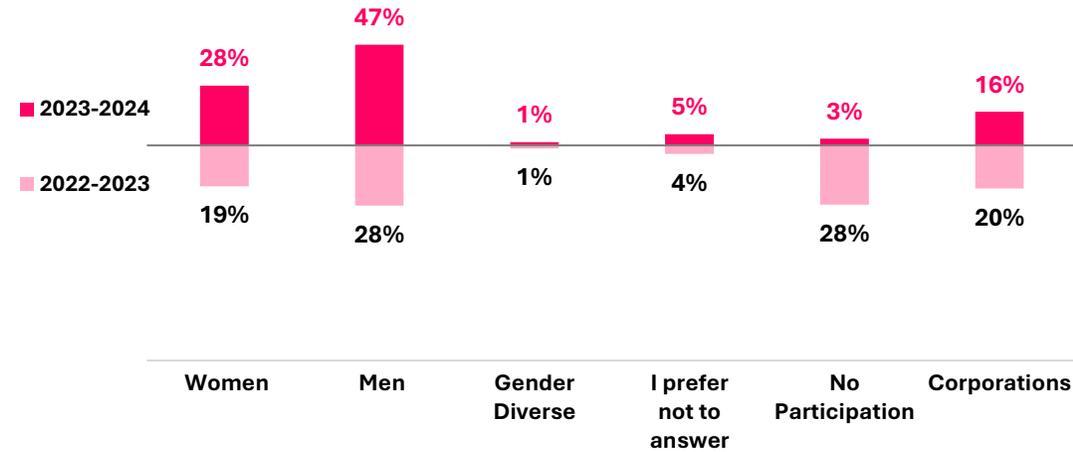
# KEY ROLES AND OWNERSHIP BY GENDER

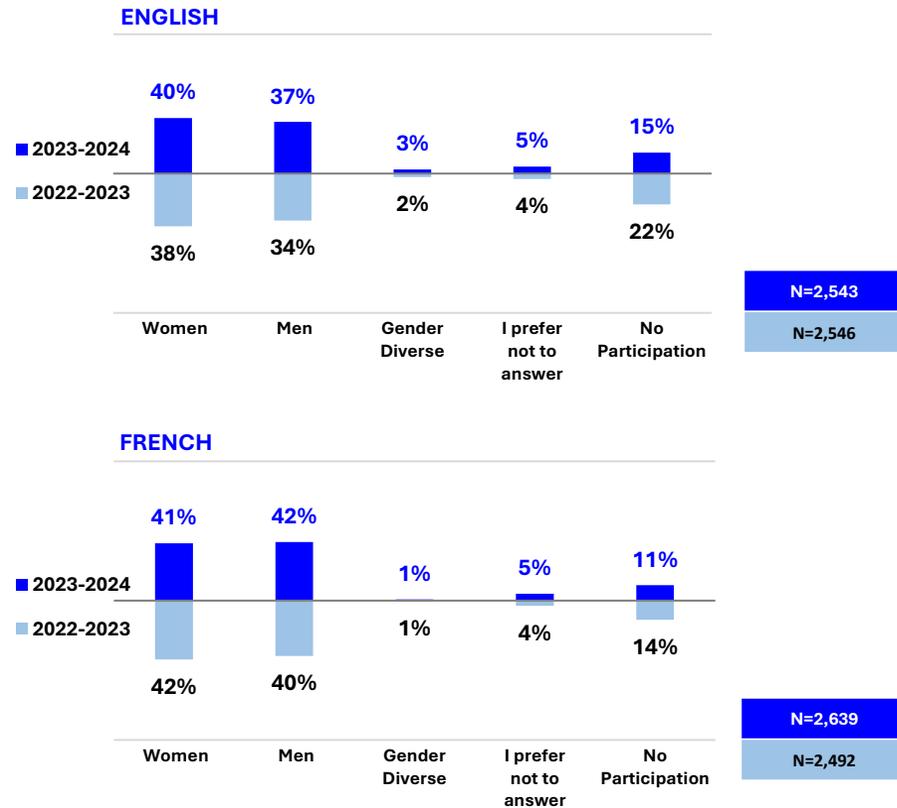

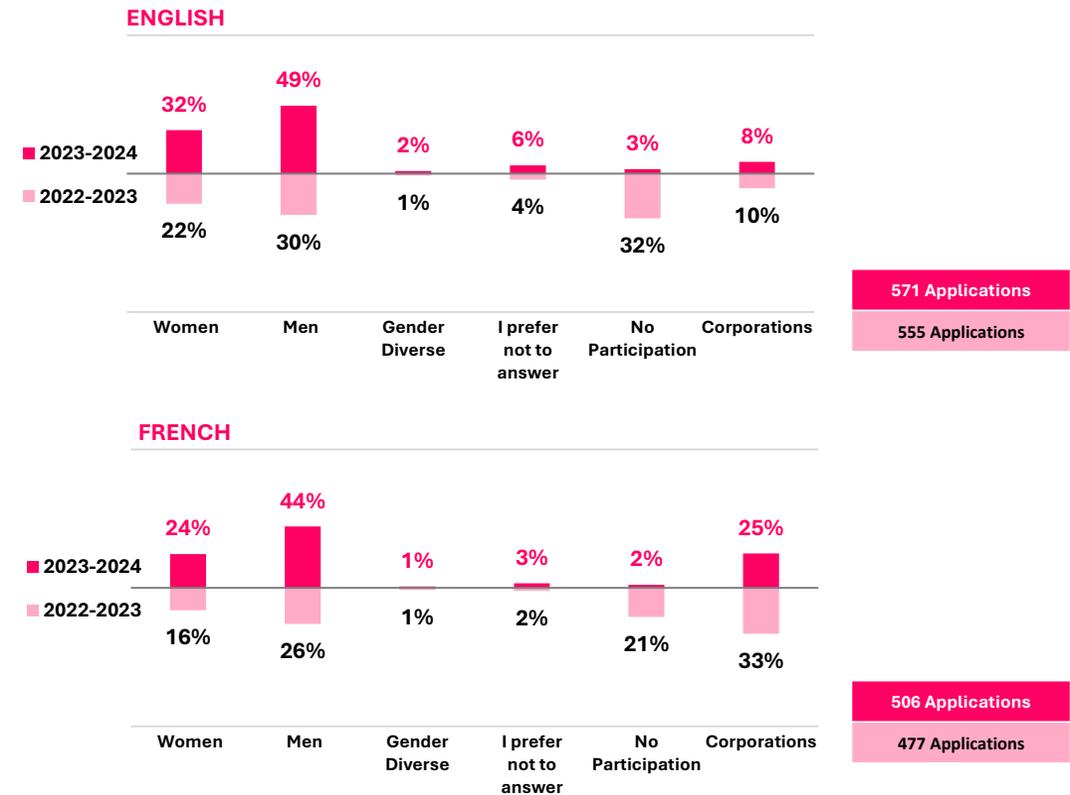
# KEY ROLES AND OWNERSHIP BY GENDER BY LANGUAGE

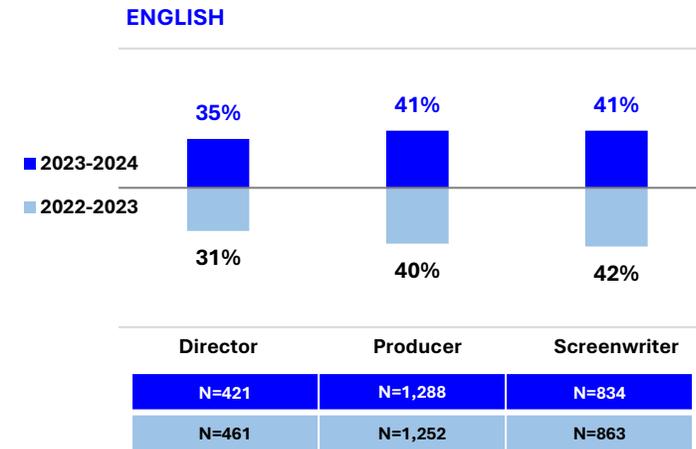
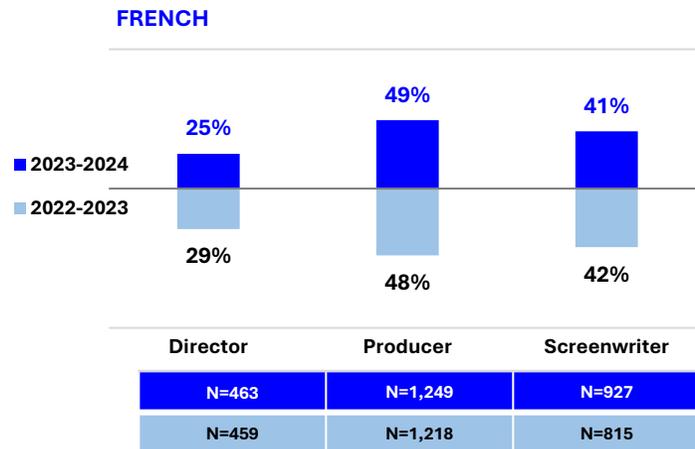

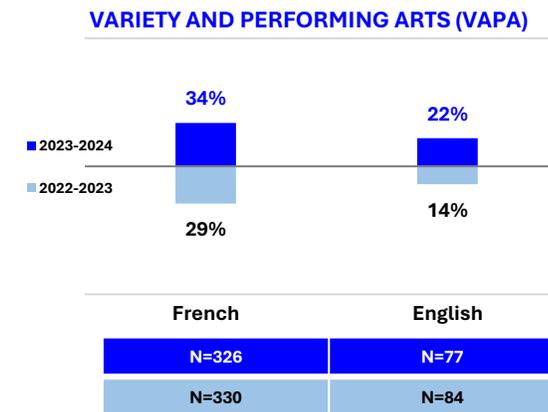

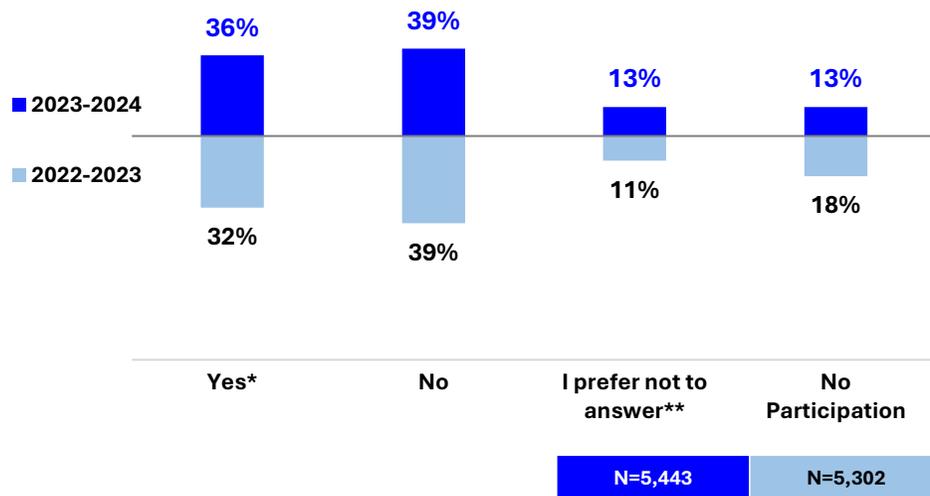

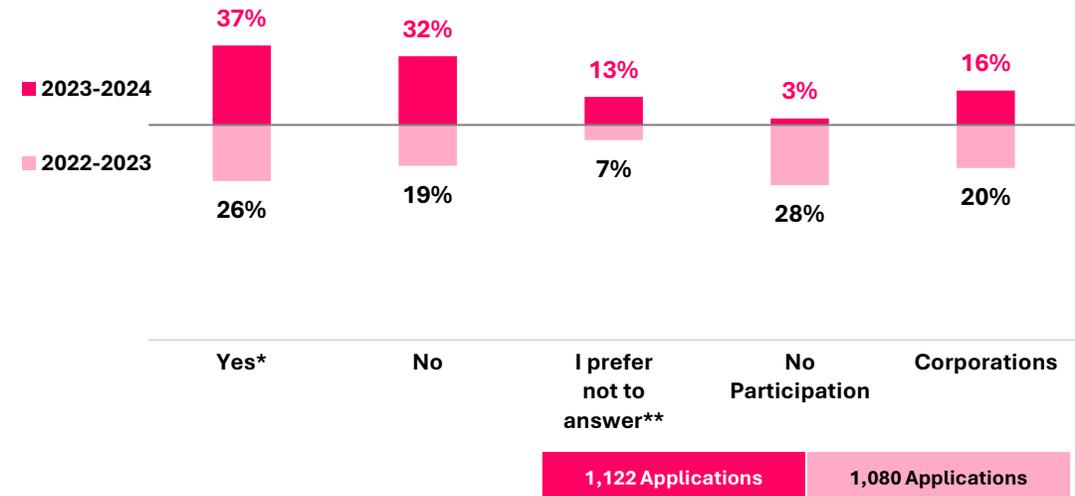

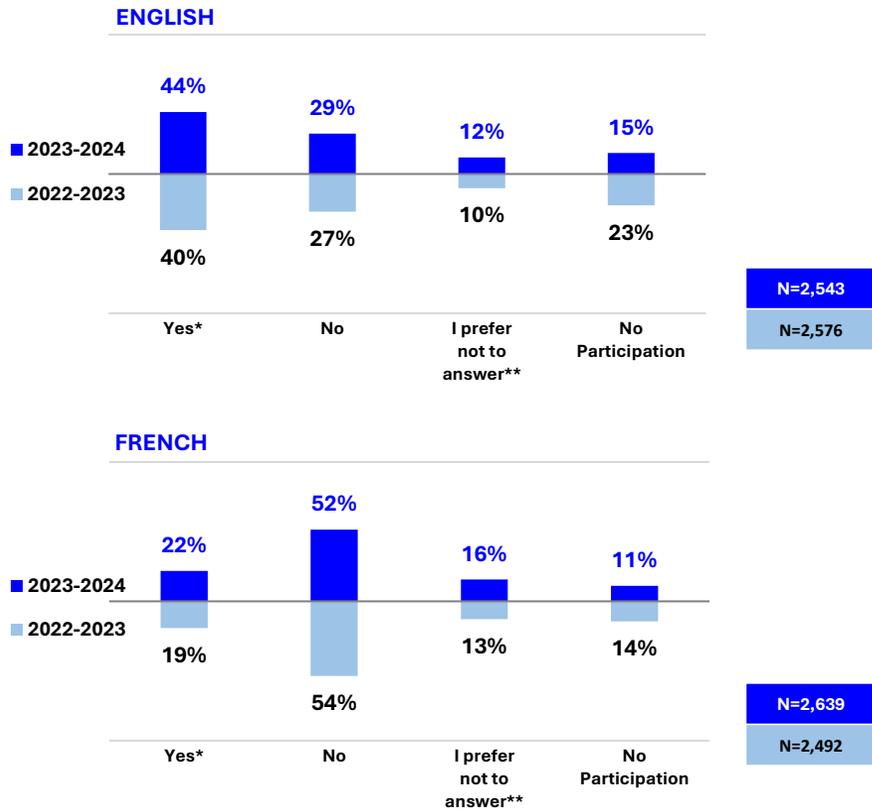

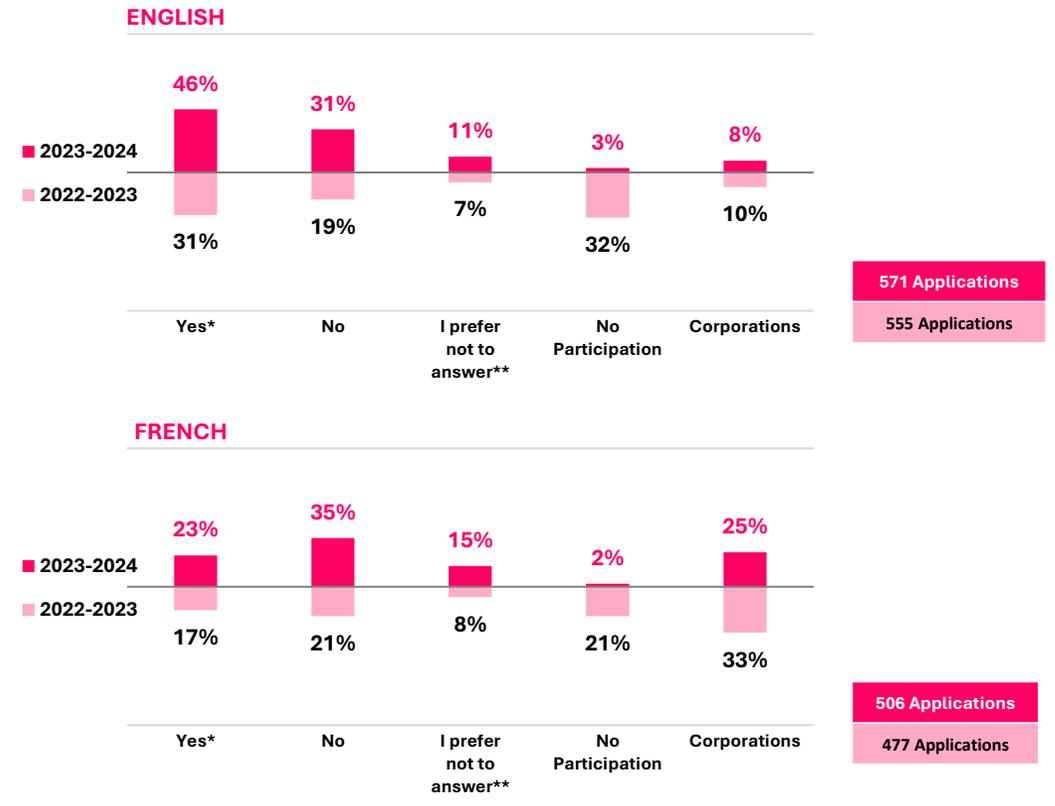
# KEY ROLES AND OWNERSHIP BY DIVERSE COMMUNITIES BY LANGUAGE

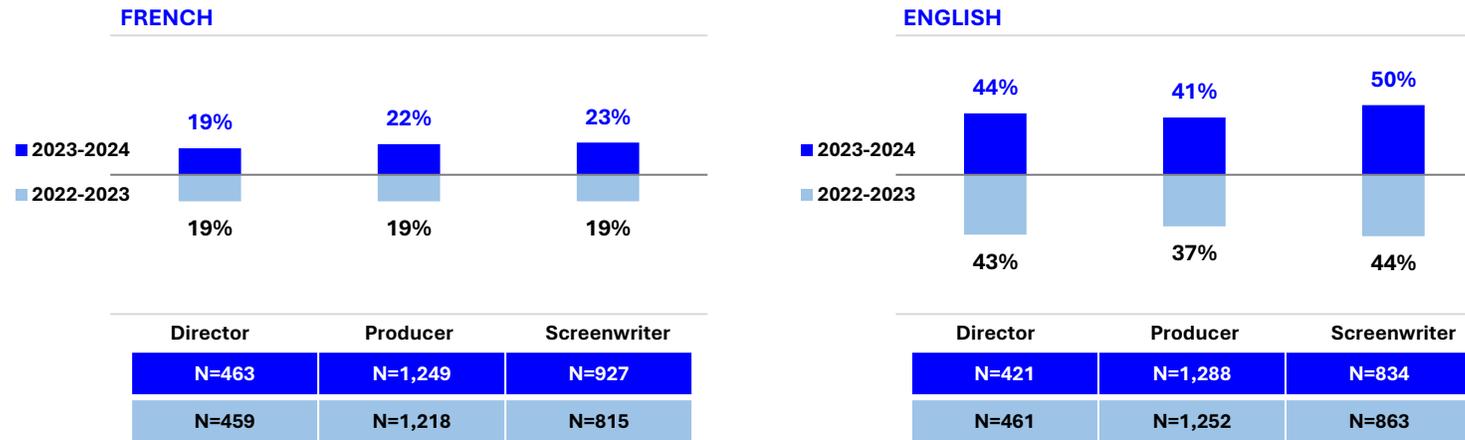

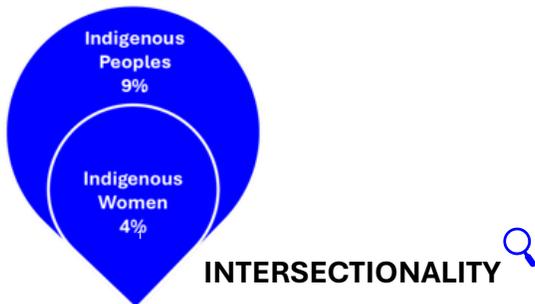
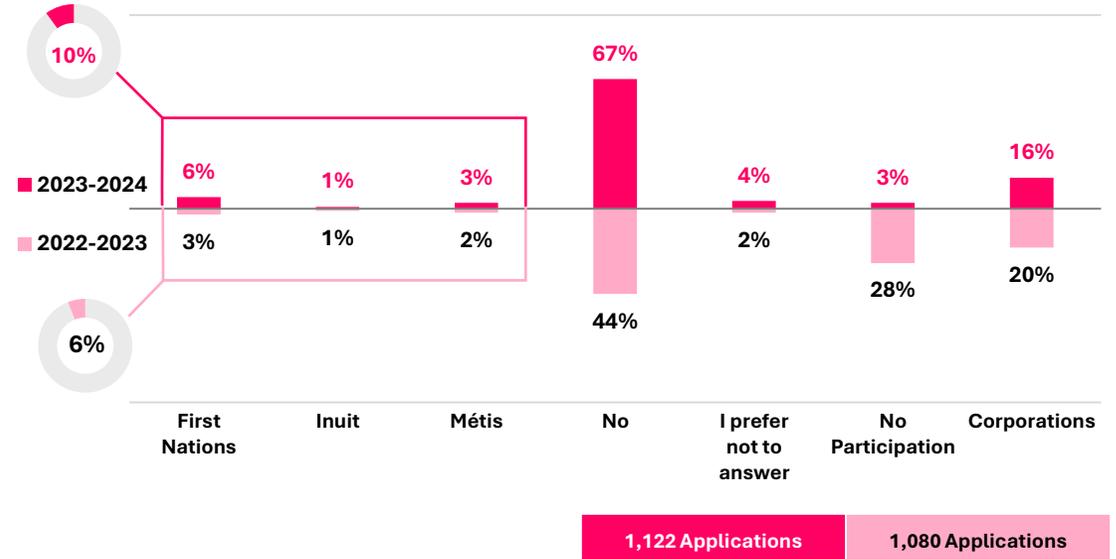
# KEY ROLES AND OWNERSHIP BY INDIGENOUS PEOPLES

Key Roles held by *Indigenous Peoples* increased slightly to 9%; *Indigenous Peoples* represented 10% Ownership of linear funded applications, reflecting increased participation

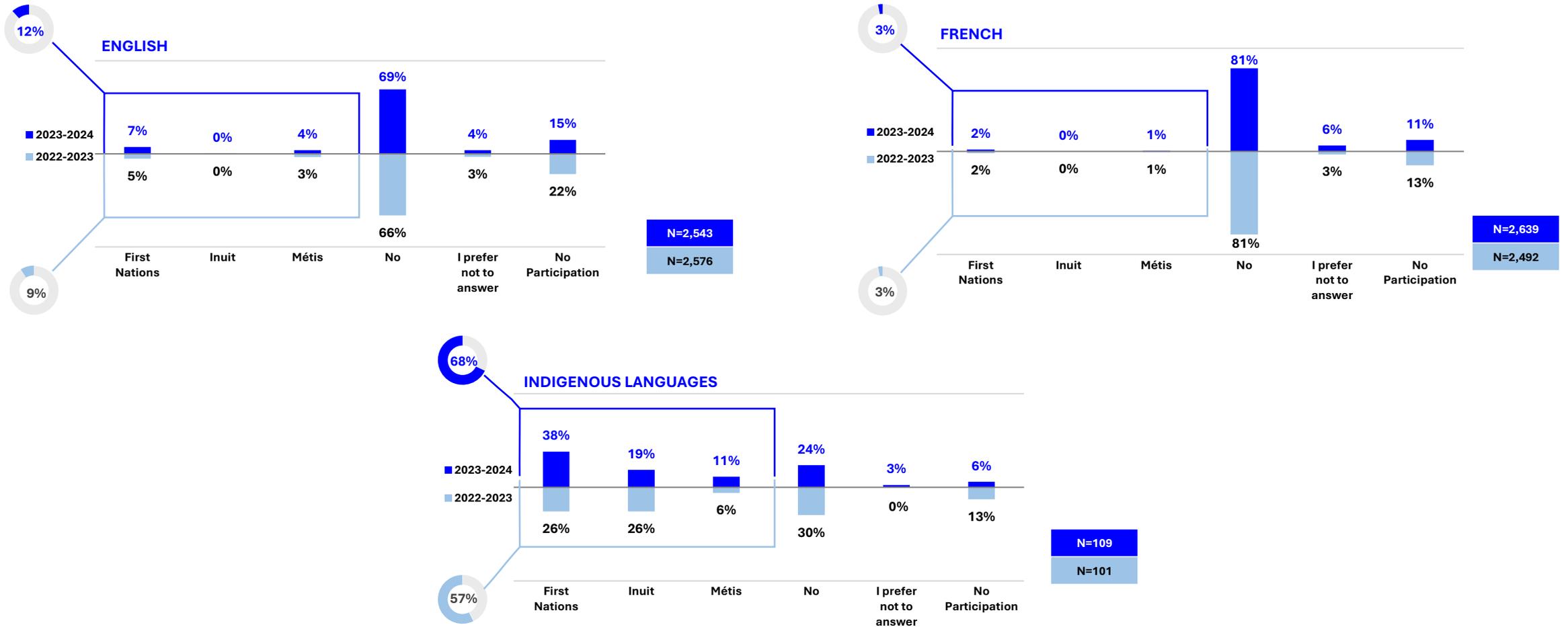

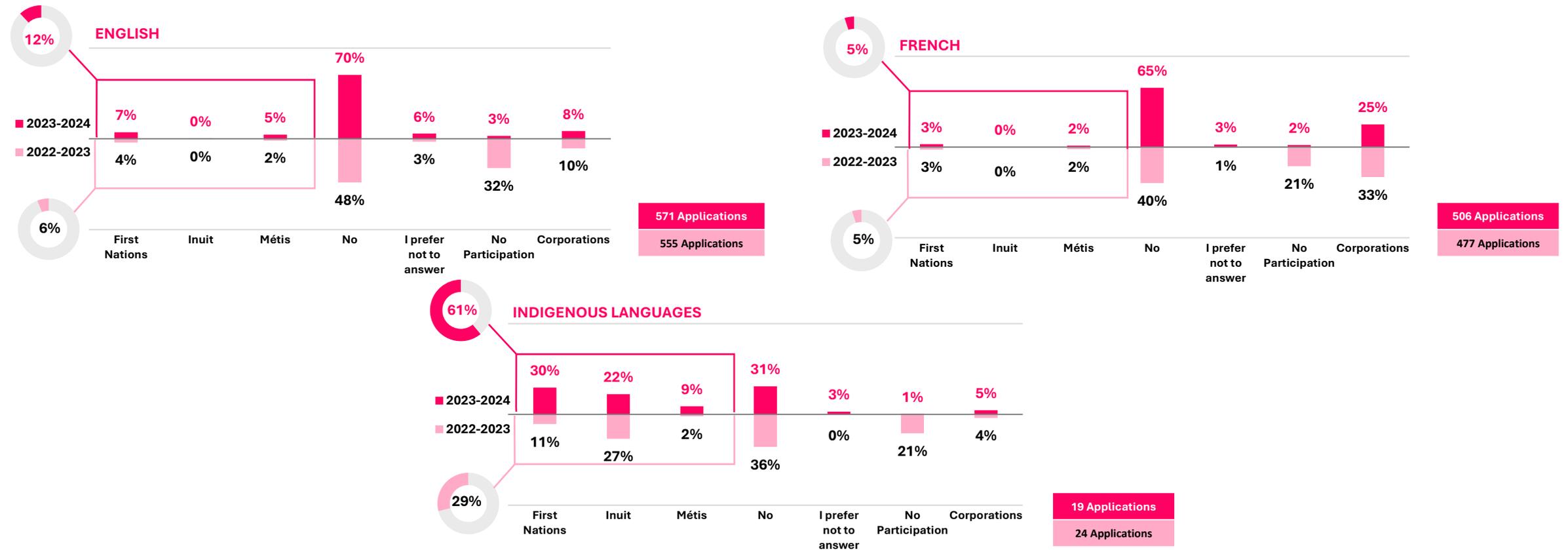

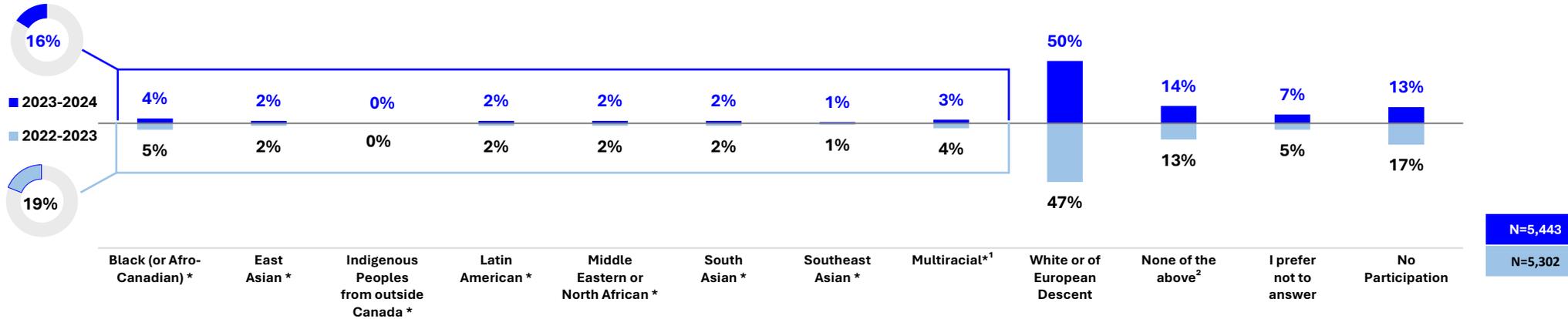

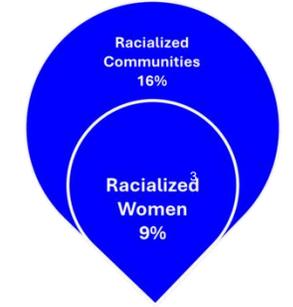

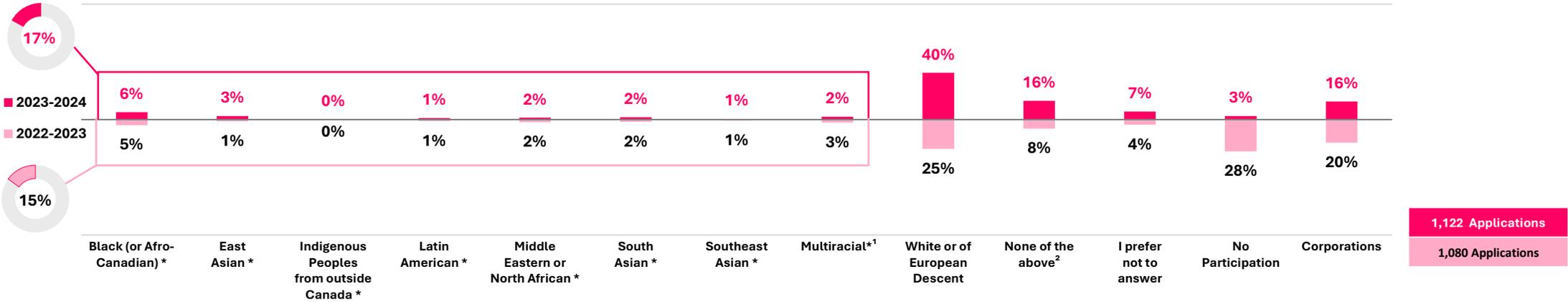

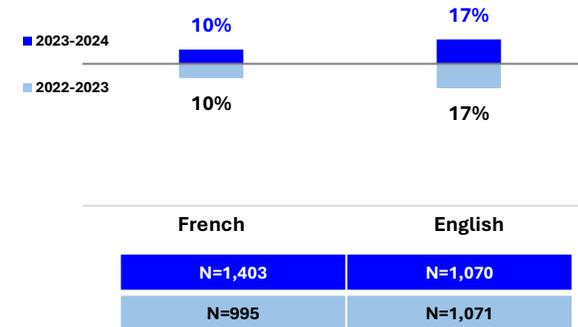

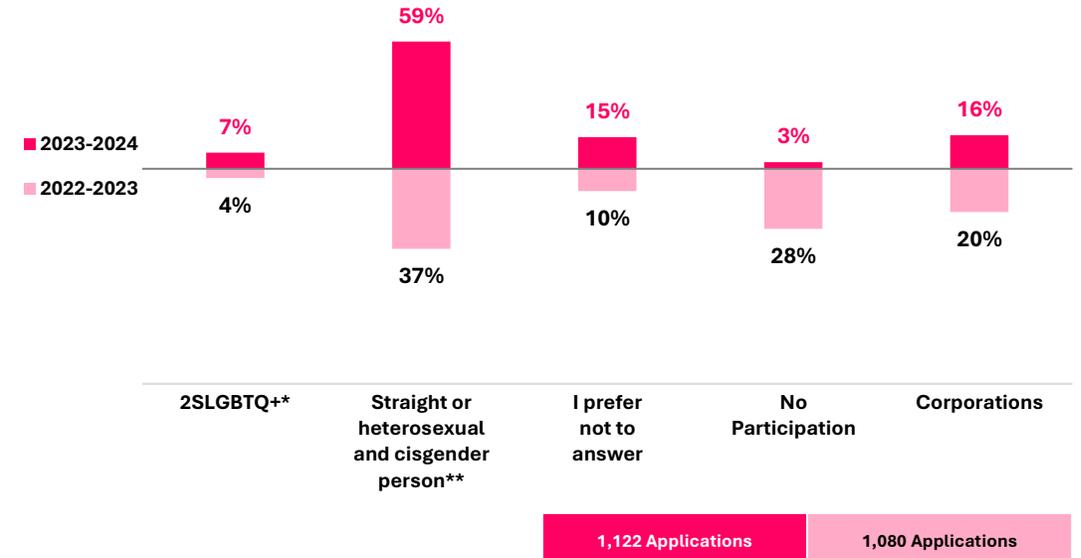

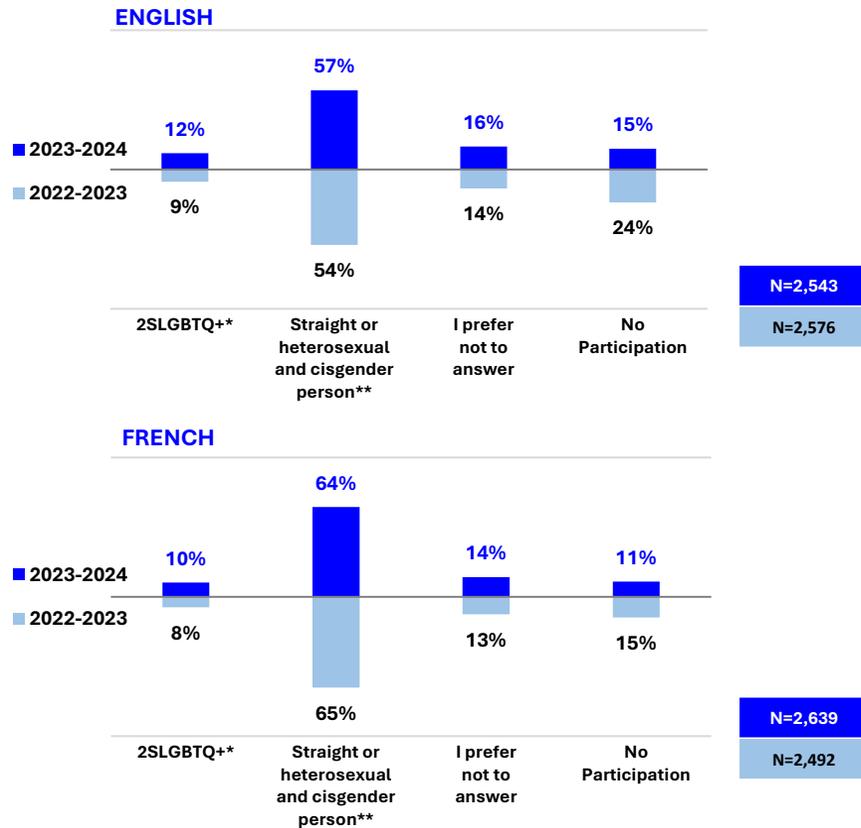

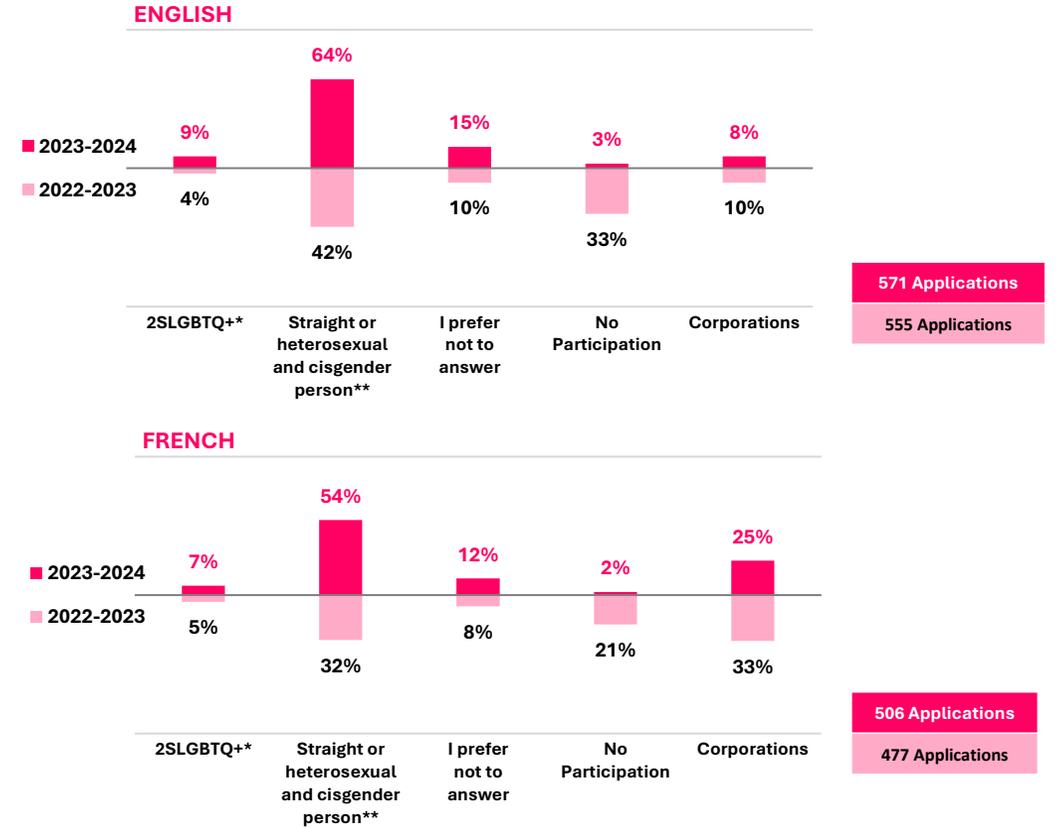

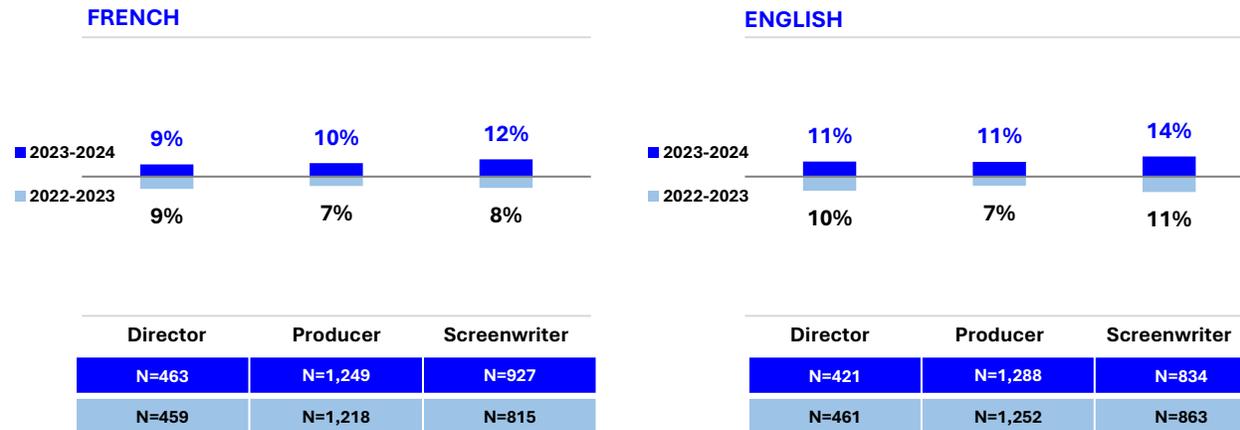

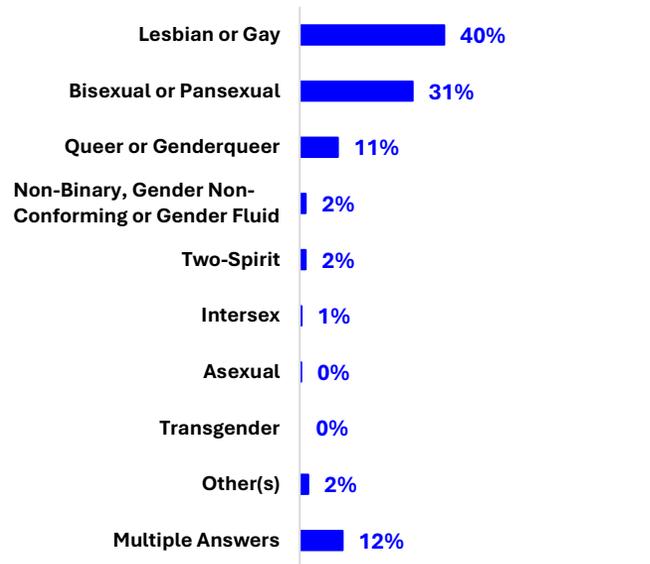

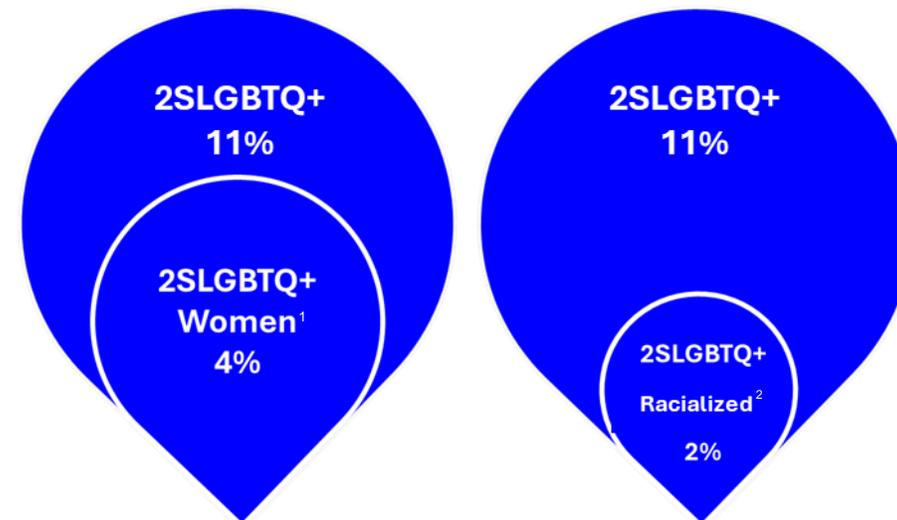

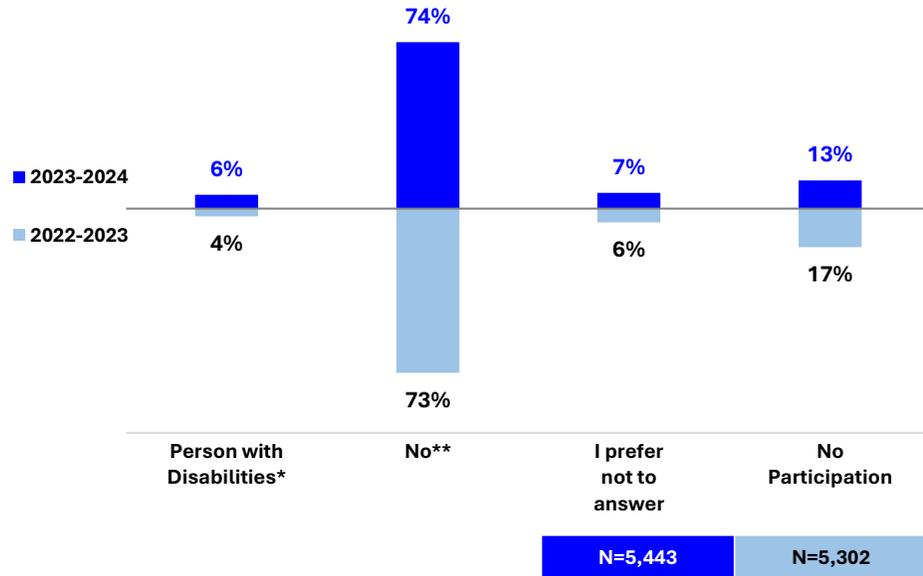

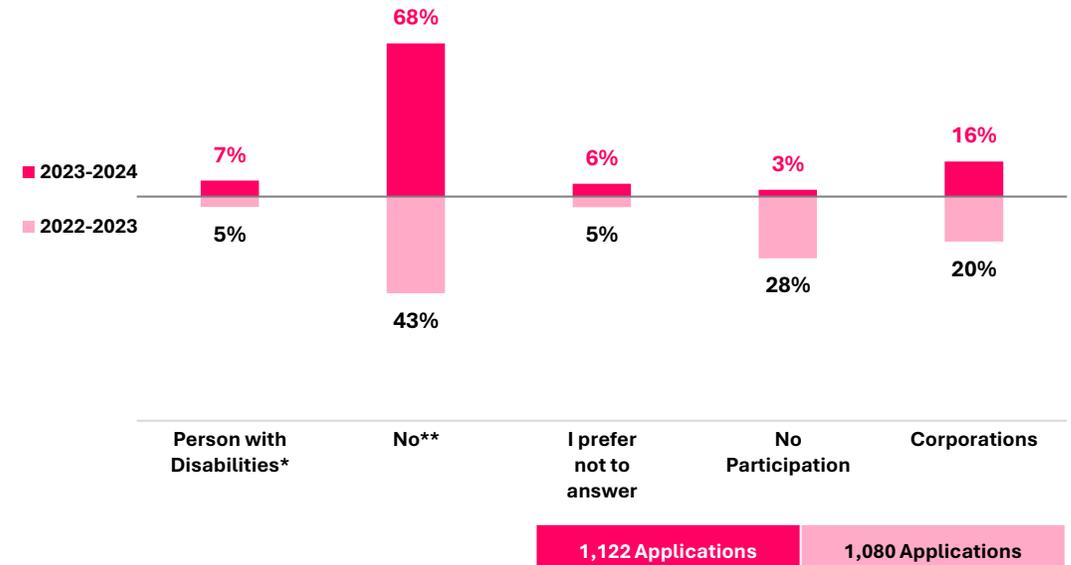

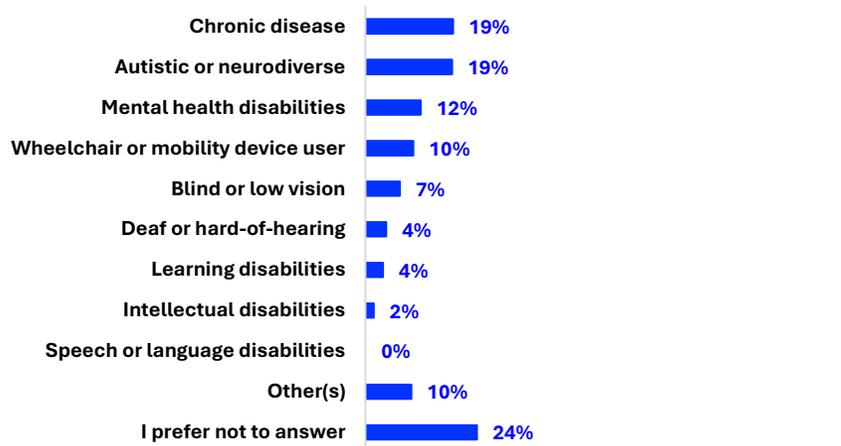

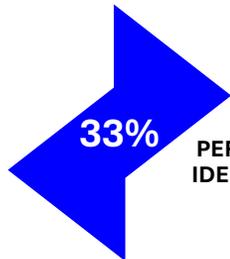

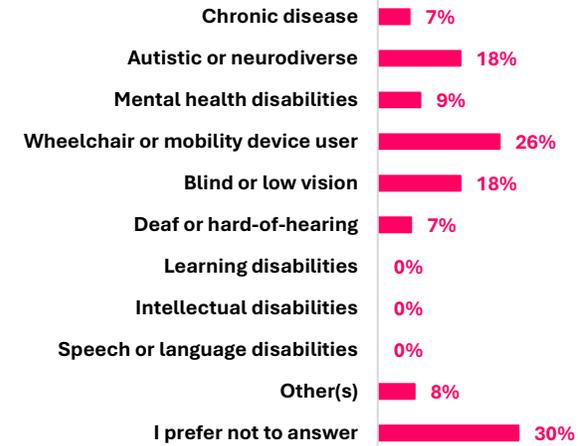

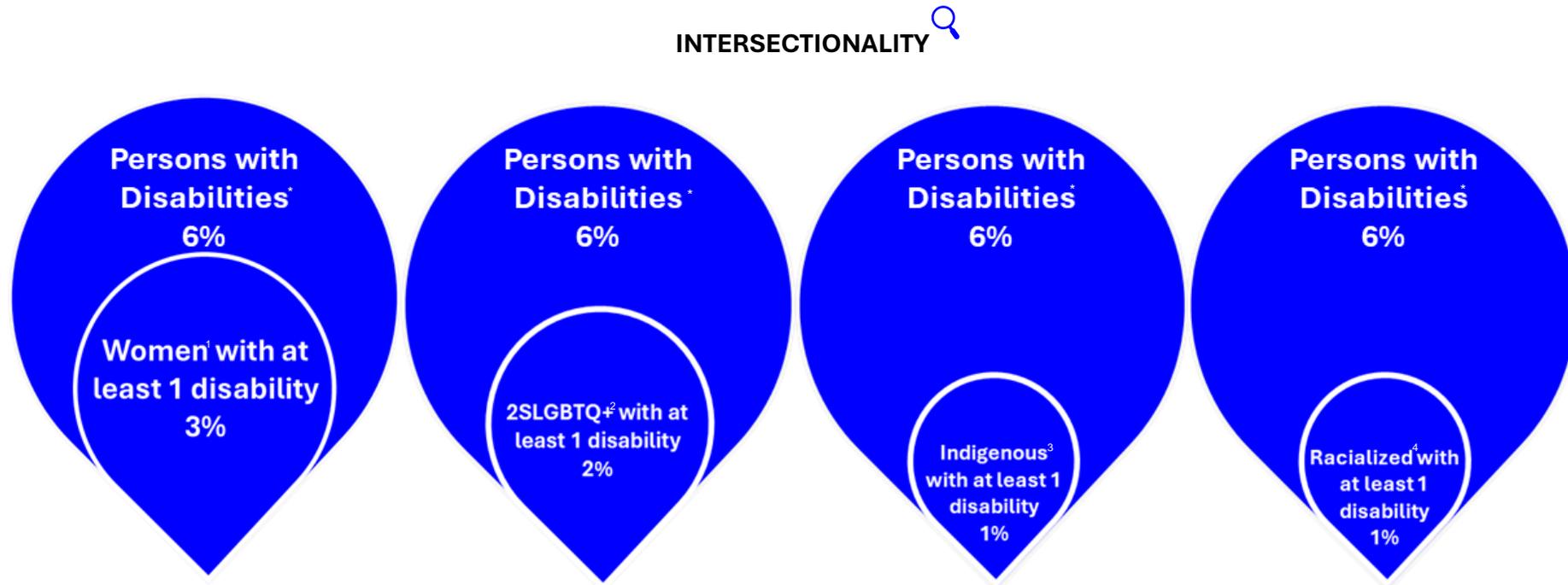

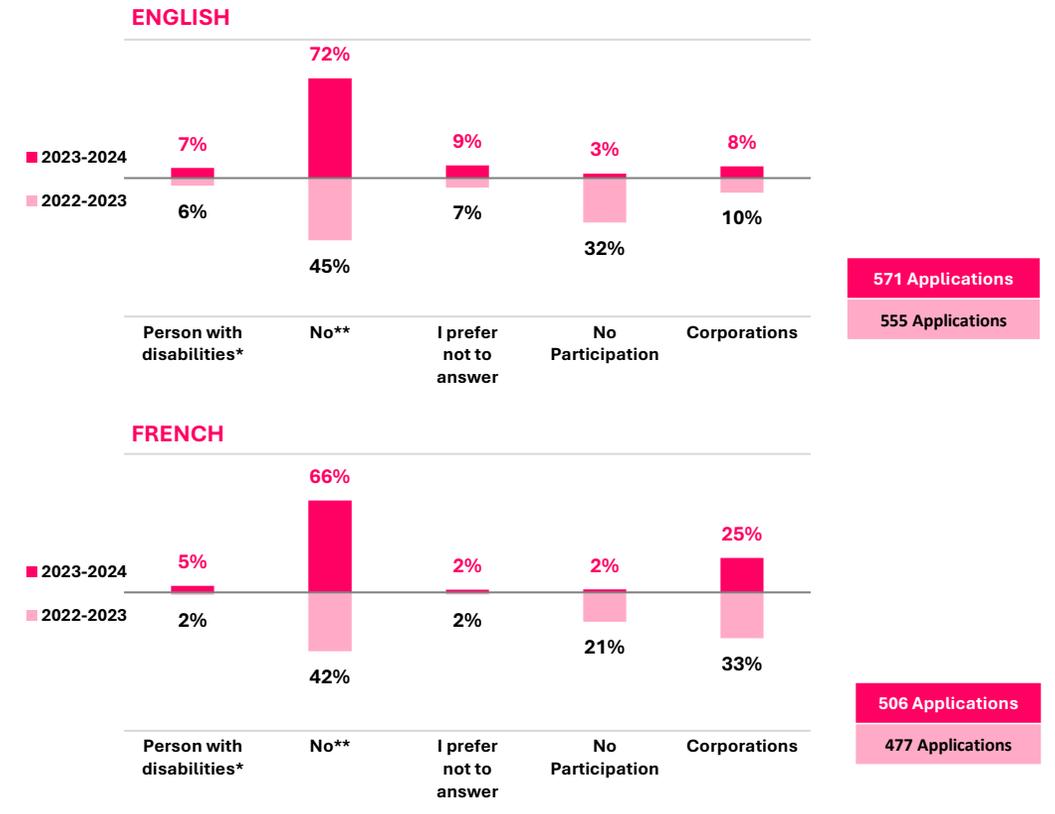

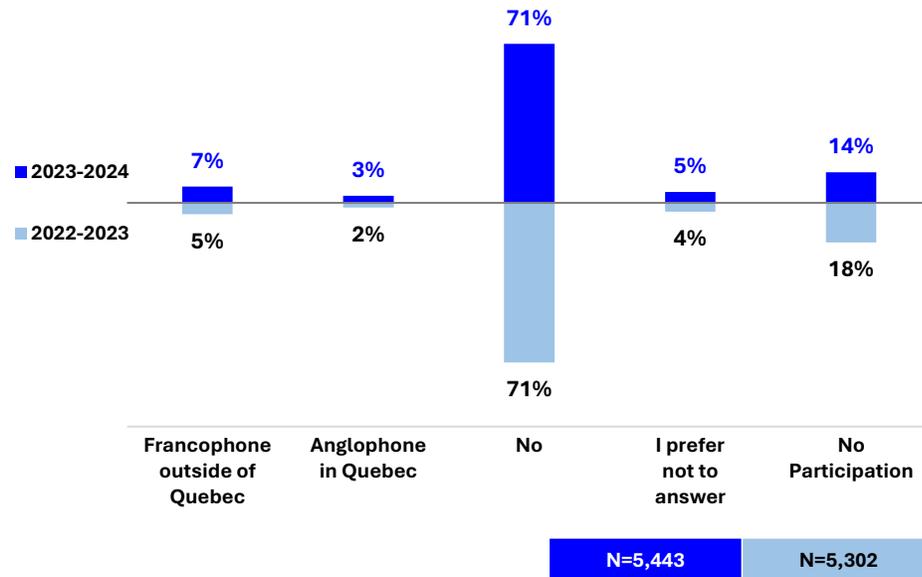

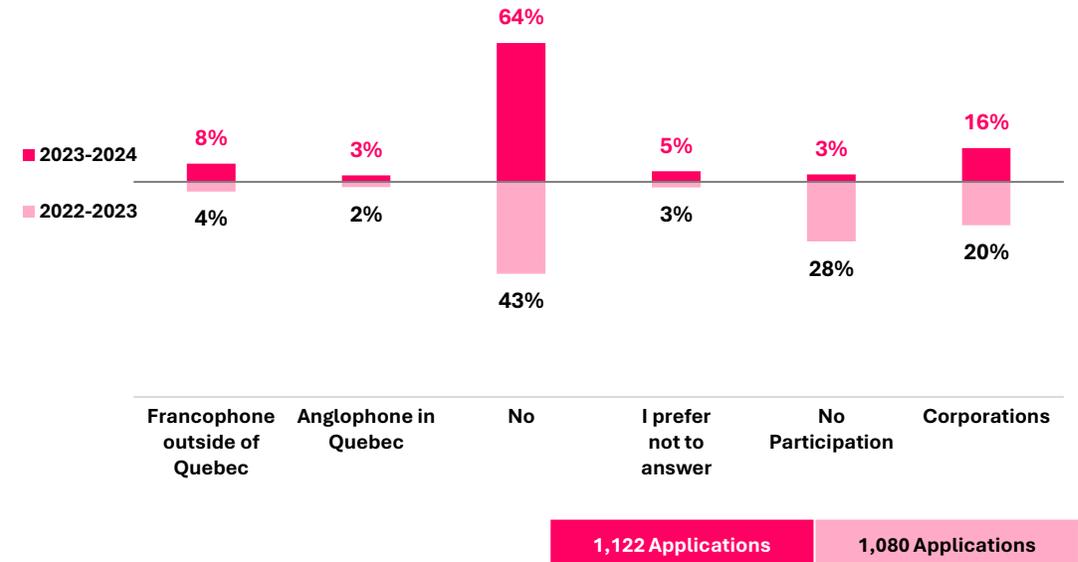

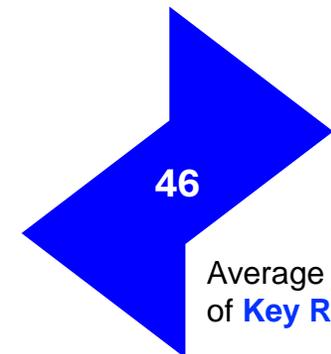
This section reports on representation in all selective programs in linear content, with an emphasis on the incentives and requirements included in these programs. Selective programs are those that include an evaluation process commonly done by an external jury or an internal review committee that assess the applications to decide on which projects are funded.

First, the section reports on the combined results for all selective programs\* by Gender and representation of Diverse Communities. It is important to note that most selective programs had a Gender Balance incentive where applications with at least 40% Key Roles held by *Women* automatically earned 2 additional weight points on their assessment grid. Similarly, these programs had a Diverse Community incentive, where applications with at least 40% Key Roles held by members of one or more *Diverse Communities* automatically earned 2 additional weight points on their assessment grid. The exception was the Pilot Program for Digital Creators which had an incentive for applicants which were majority owned (51%+) by Women and one for those majority owned (51%+) by members of Diverse Communities.

This section then focuses on the **Indigenous Program** and the **Pilot Program for Racialized Communities** (PPRC) in production. These two programs had requirements for Key Roles and Ownership shares held by specific identities as well as Gender Balance incentives. The report then focuses on the **Pilot Program for Digital Creators**.



Key Roles reported in funded projects



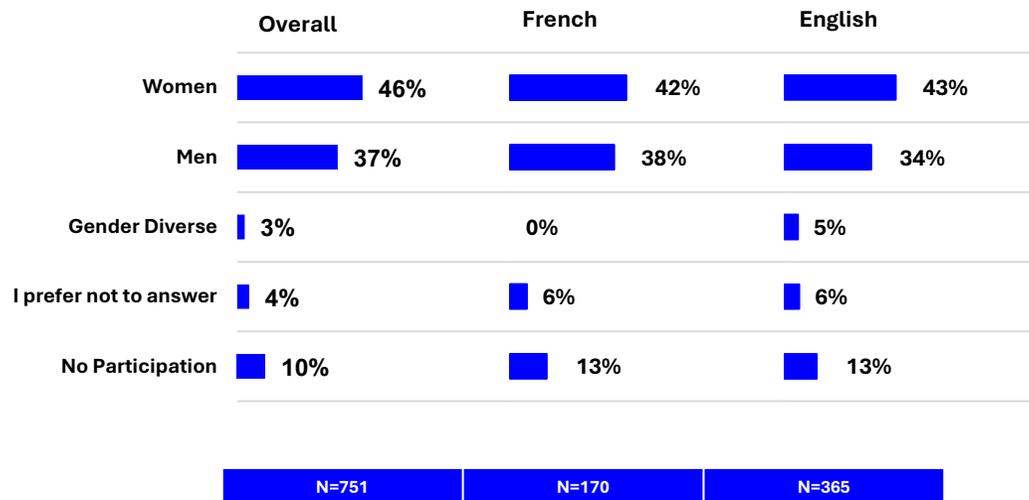

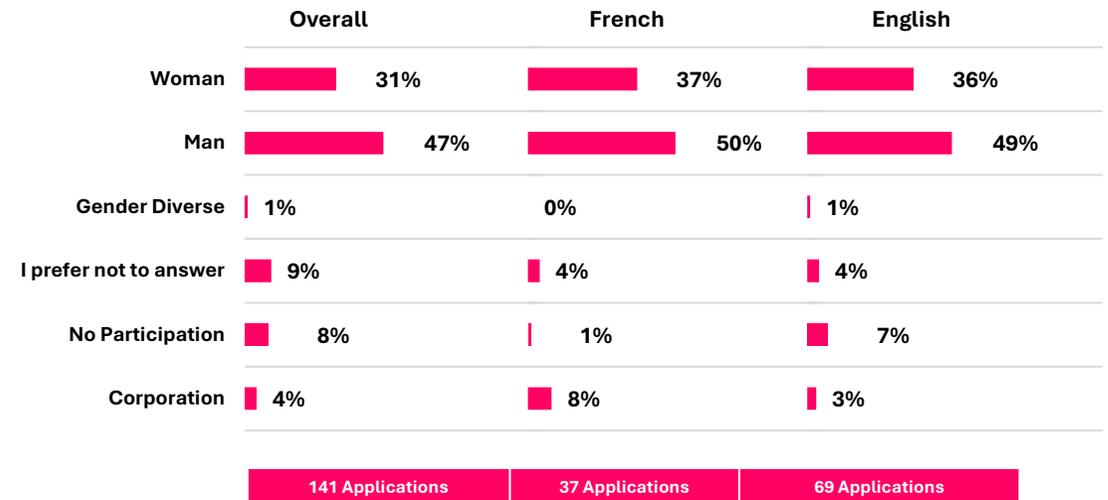

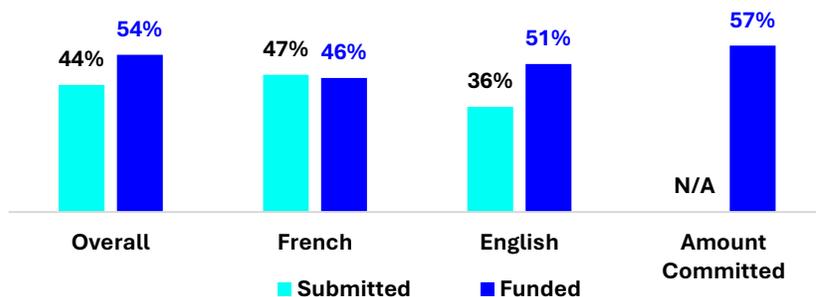

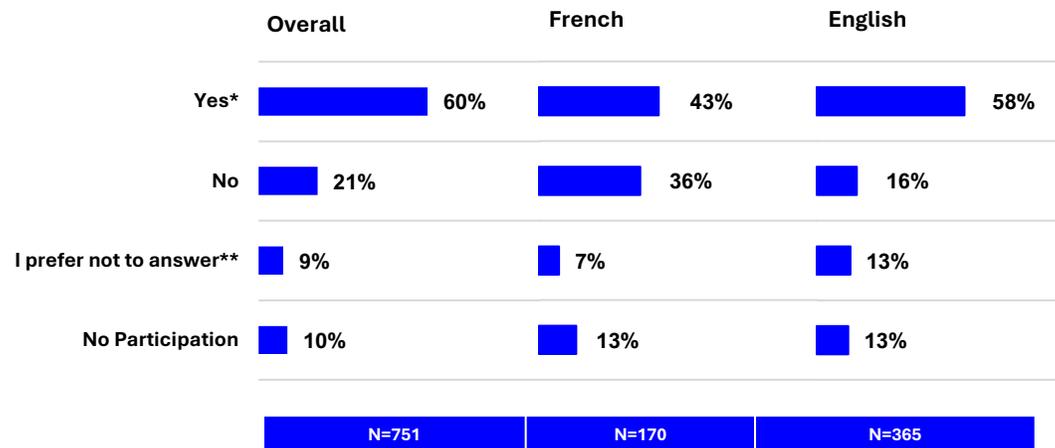

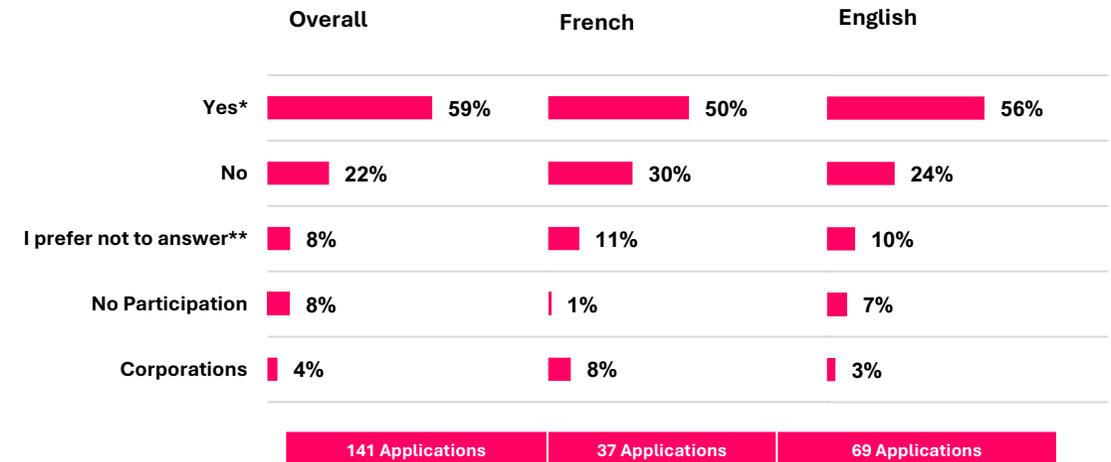

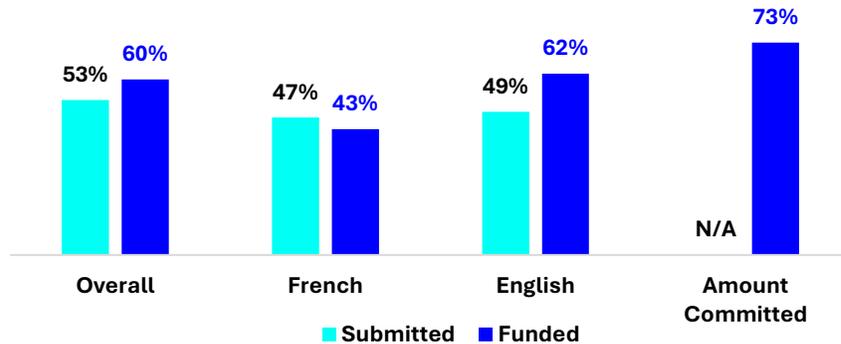

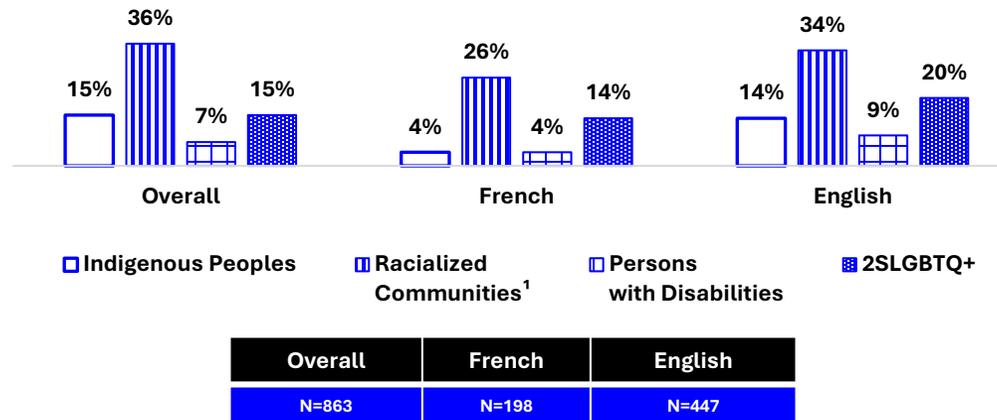

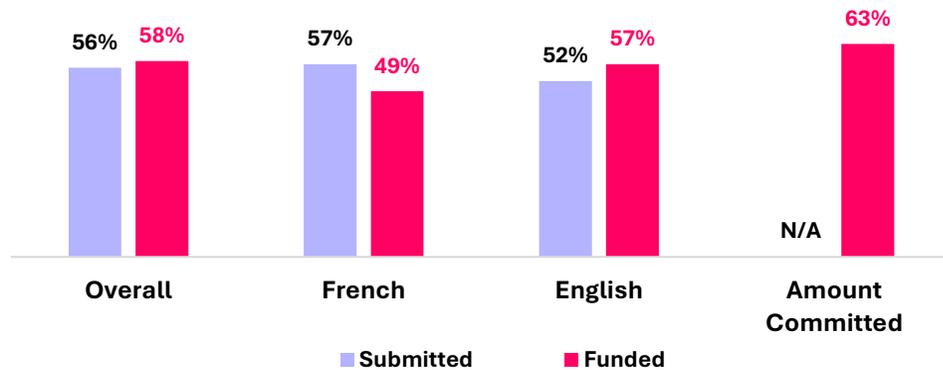

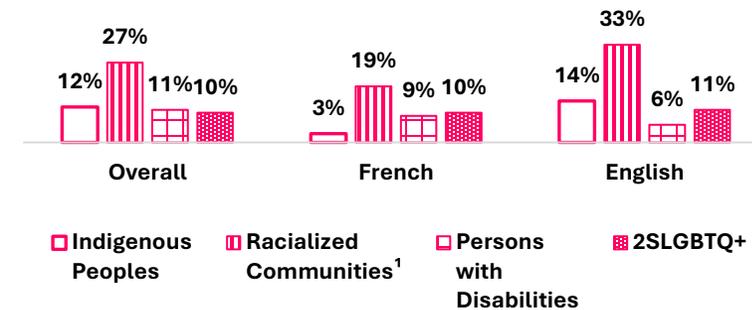

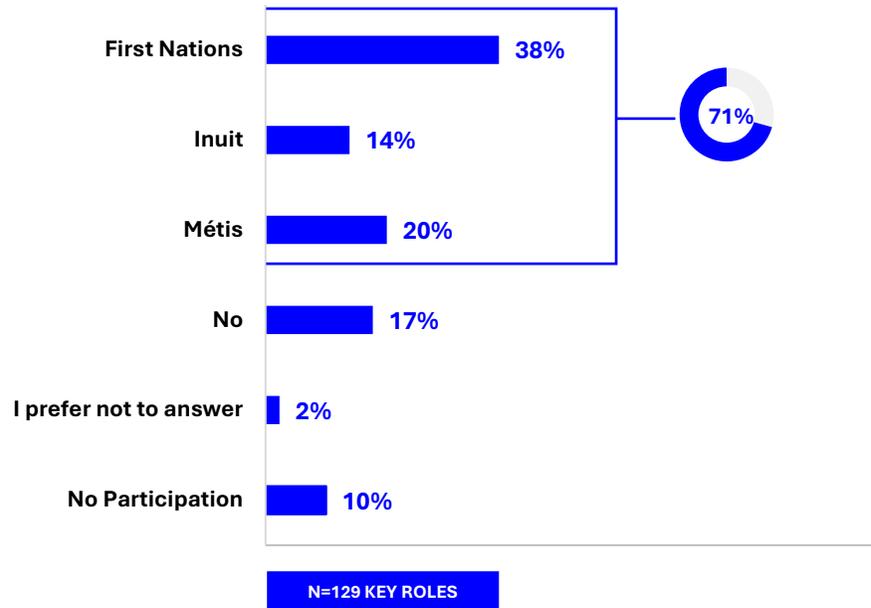

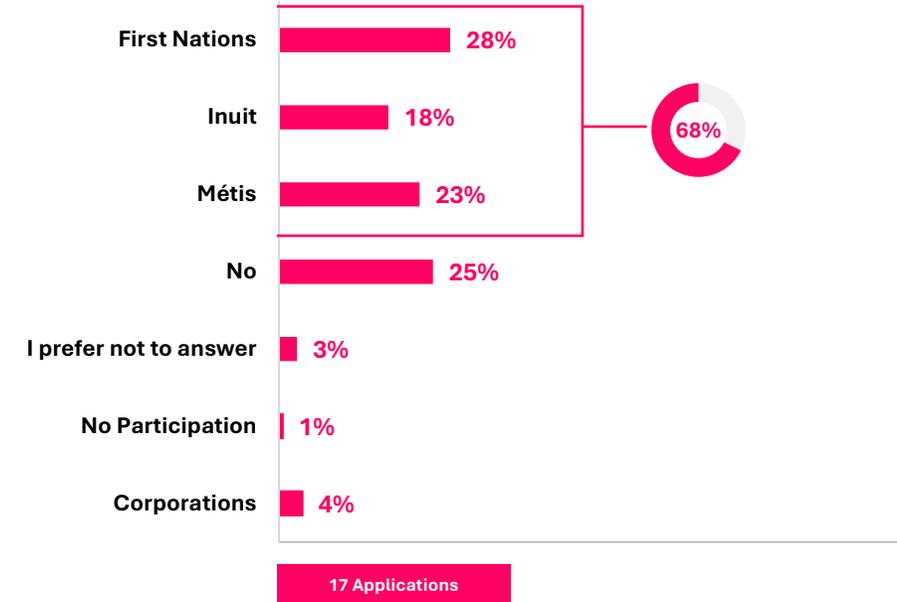

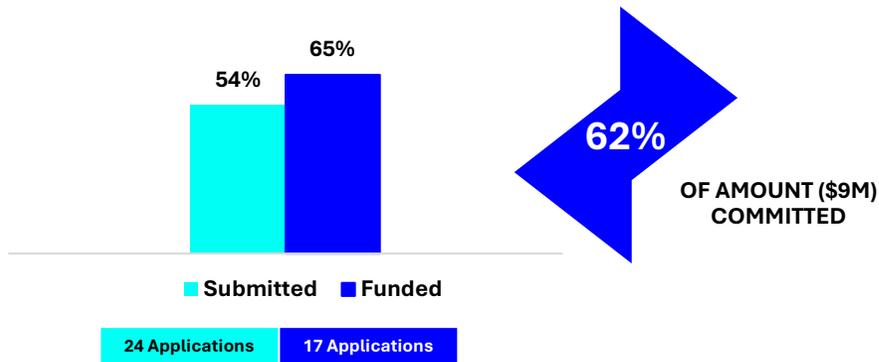

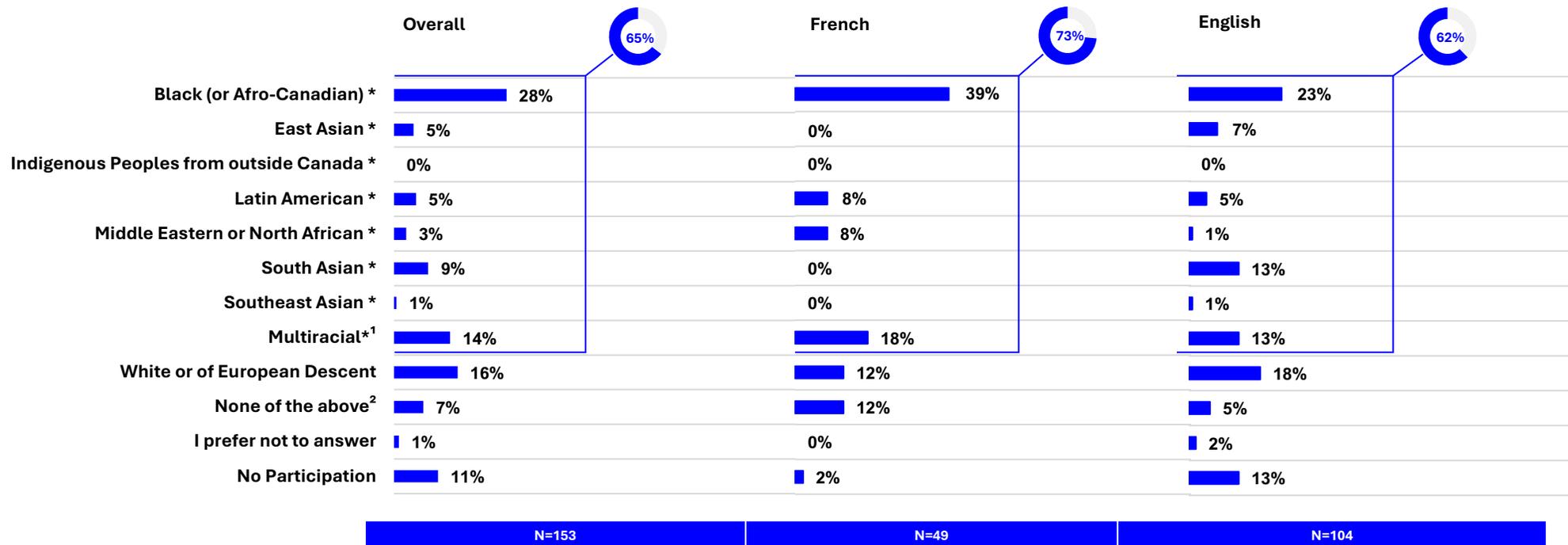

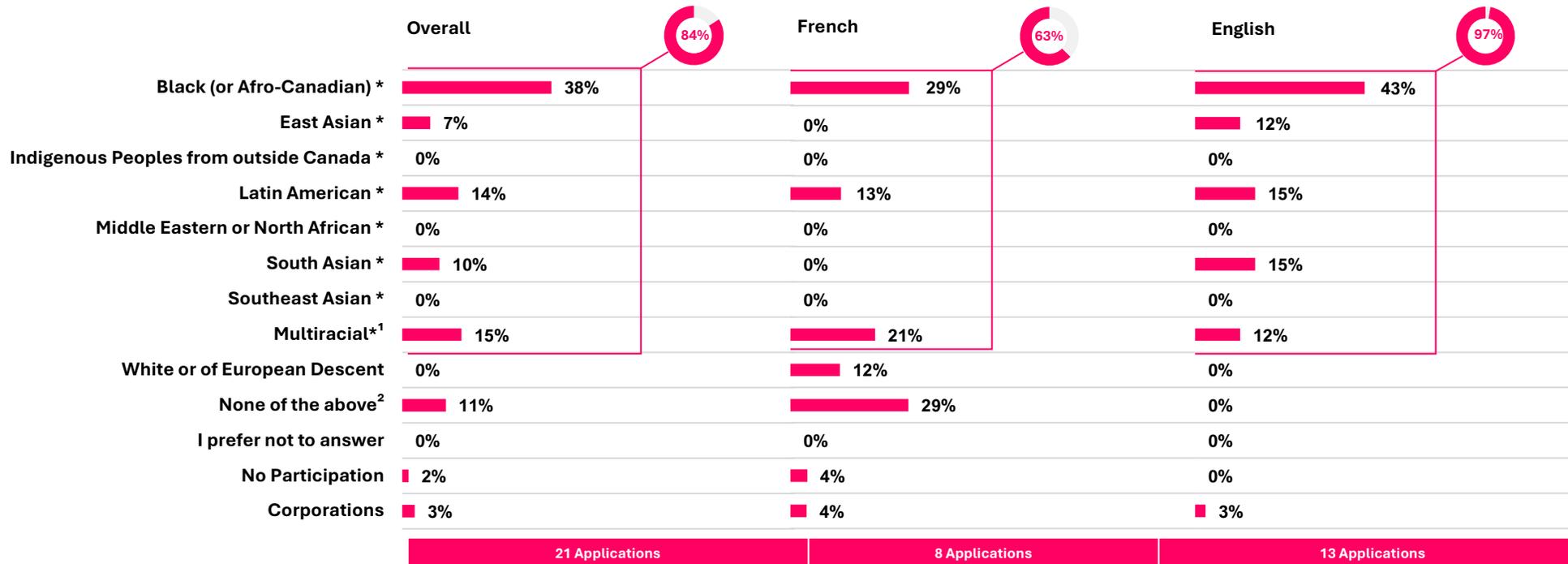

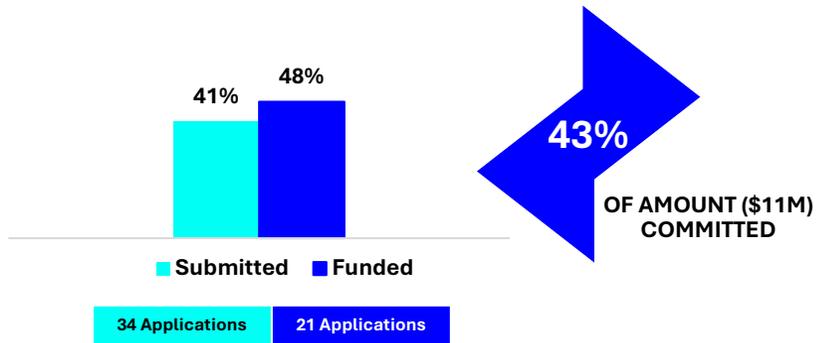

APPLICATIONS WITH 40%+ WOMEN IN KEY ROLES FOR PPRC PRODUCTION - 2023-2024



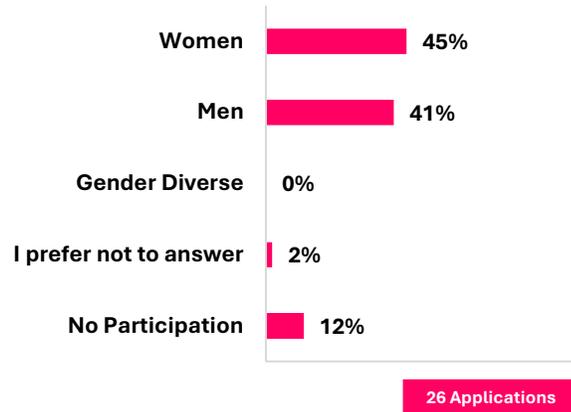

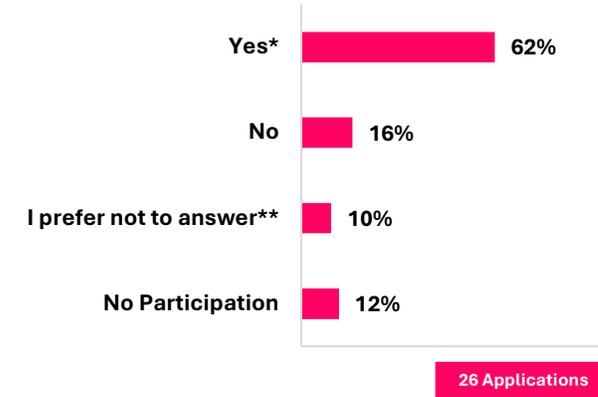

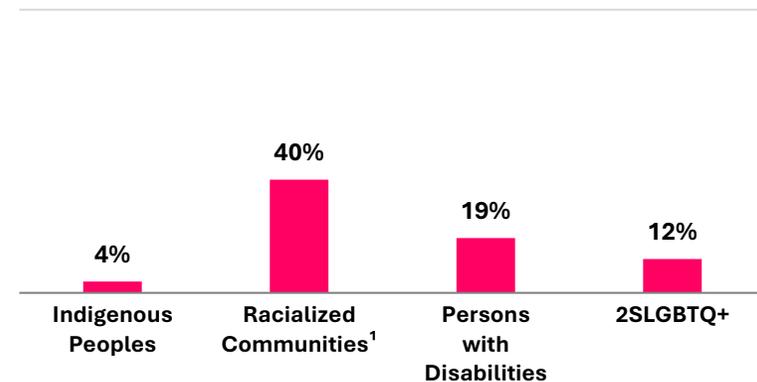
GENDER REPRESENTATION IN OWNERSHIP FUNDED APPLICATIONS - 2023-2024

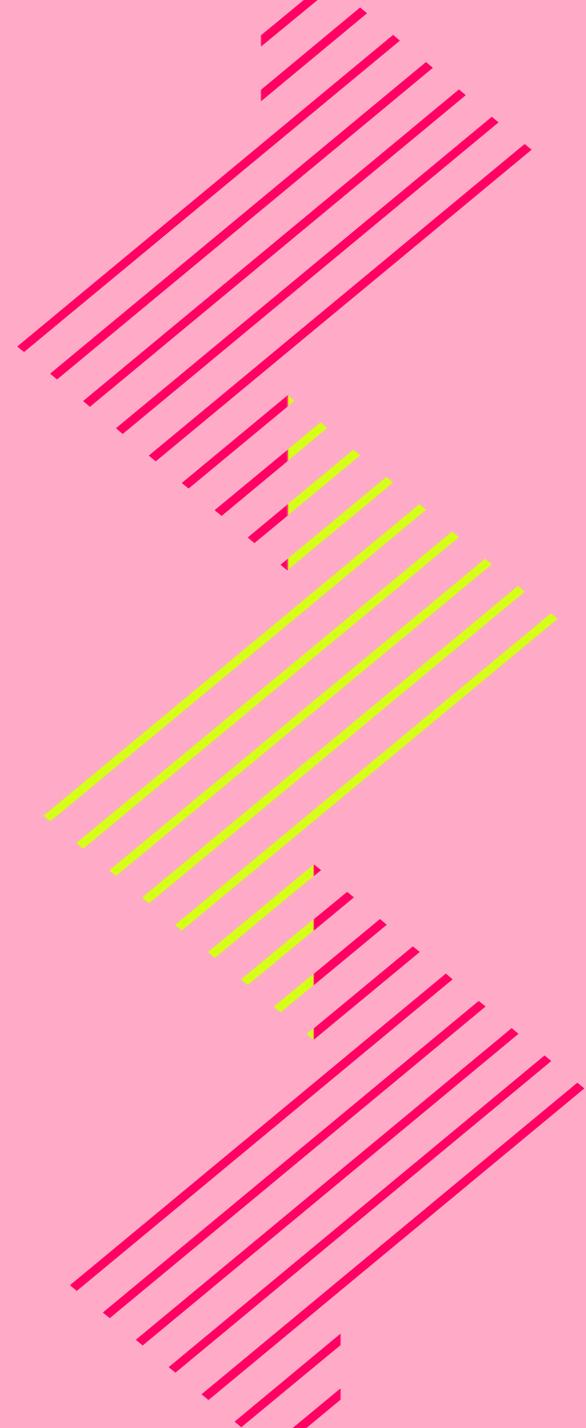

# REPRESENTATION IN LINEAR AUTOMATIC PROGRAMS

This section reports on representation in all linear content Programs that can be accessed on a first-come, first-served basis and through the Envelope Programs\*, called Broadcasters Envelopes, since April 2024.

To calculate the envelope allocation of each broadcaster every year, the CMF uses a system of credits and factors including the **Diverse Community Licence Factor**. In 2023-2024, this factor accounted for 10% of the total credits of each broadcaster, calculated based on the amount of their envelope committed towards projects by an Applicant company with majority ownership by members of Diverse Communities.\* Other factors included Audience Success, Historic Performance, Regional Production Licences, and OTT First Run Licences.

All eligible broadcasters were also required to demonstrate that at least 50% of their envelope funding went to support projects with 40% or more Key Roles held by *Women*. Small broadcasters were exempt from this requirement.

Because of these requirements and incentives, the results focus on the representation of Women and members of Diverse Communities.

The results in the section are divided as follows:

- ✦ **Overall Representation in Automatic Programs:** results for Gender and Diverse Communities in all automatic programs combined.
- ✦ **Performance Envelope+ (PE+):** the Performance Envelope is the largest funding program at the CMF. For this report, the program has been combined with other related production incentives such as the Anglophone Minority Incentive and other Regional Incentives (English Regional Production Bonus, Northern Incentive, and the Québec French Regional Production Incentive).
- ✦ **Development Envelope+ (DE+):** includes the Development Envelope, Francophone Minority Development, Northern Development, and Québec Regional Development.
- ✦ **Indigenous Program - Development and Predevelopment**
- ✦ **Pilot Program for Racialized Communities (PPRC) – Development and Predevelopment**

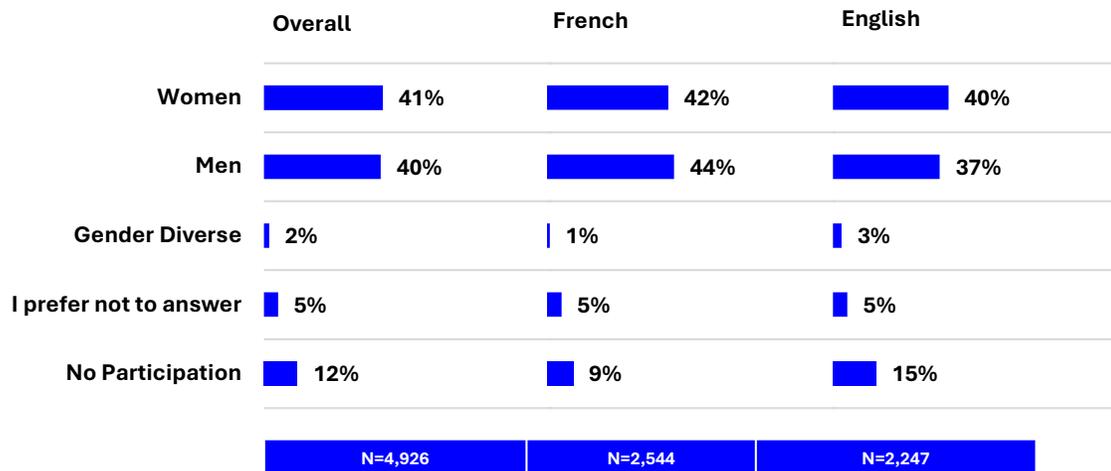

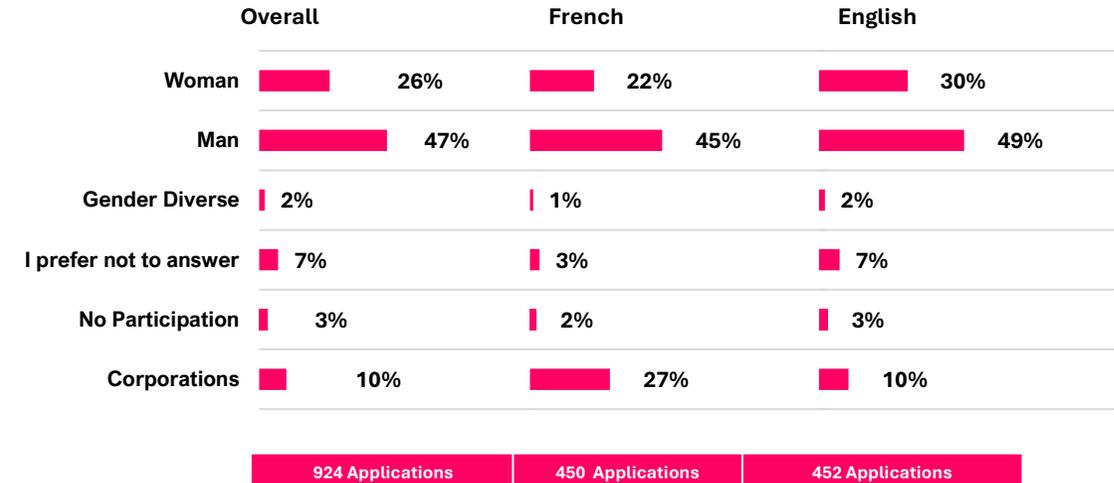

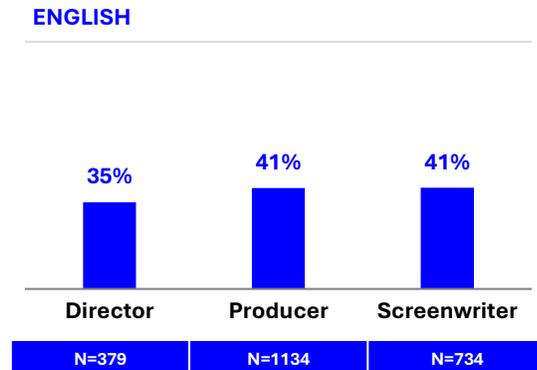
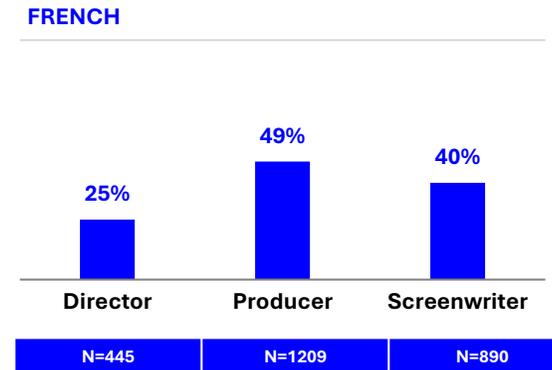

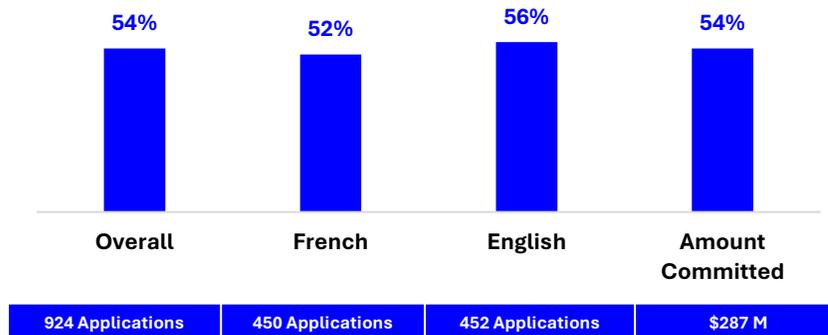

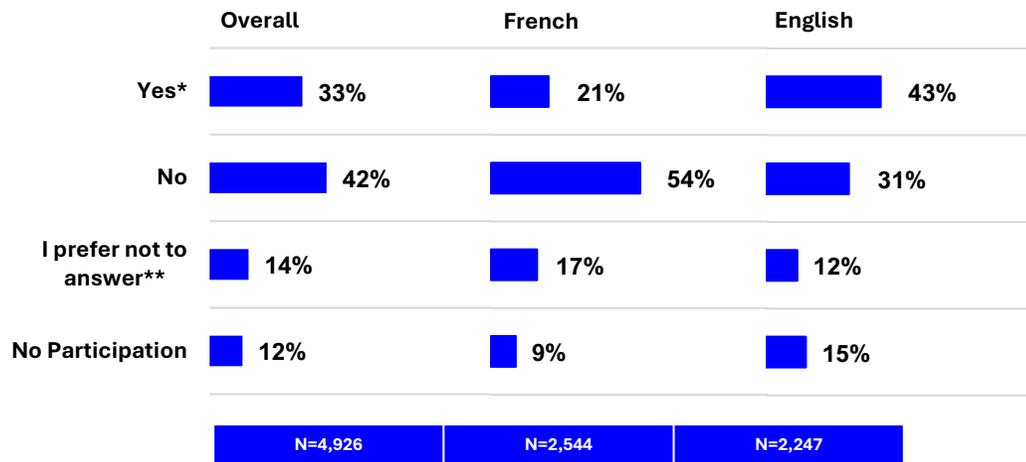

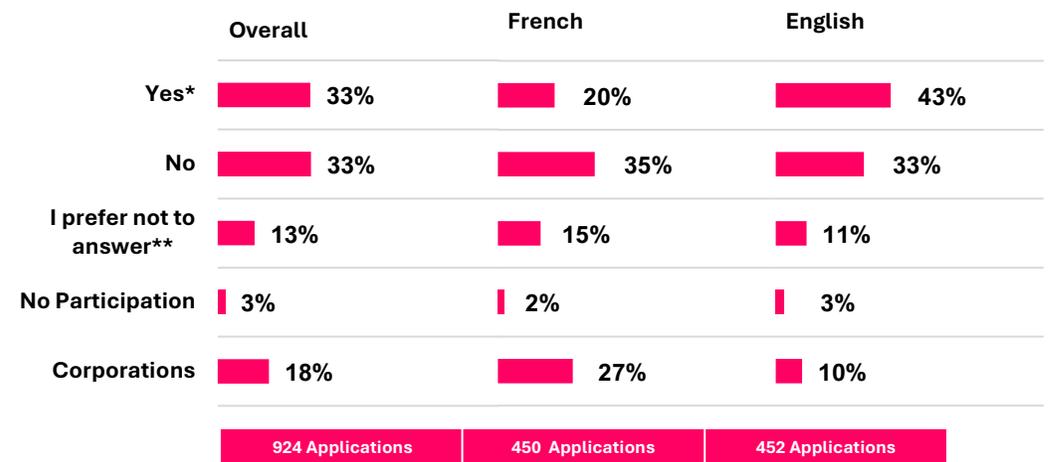

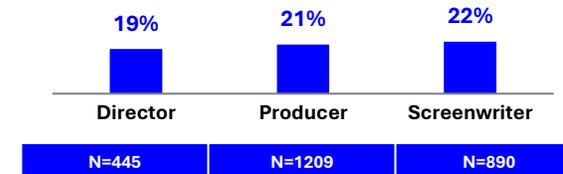

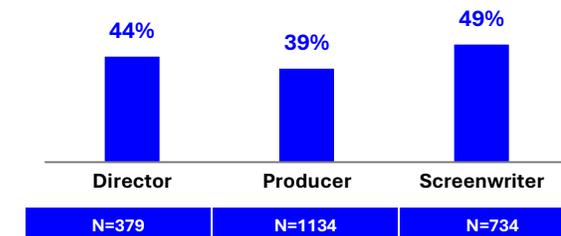

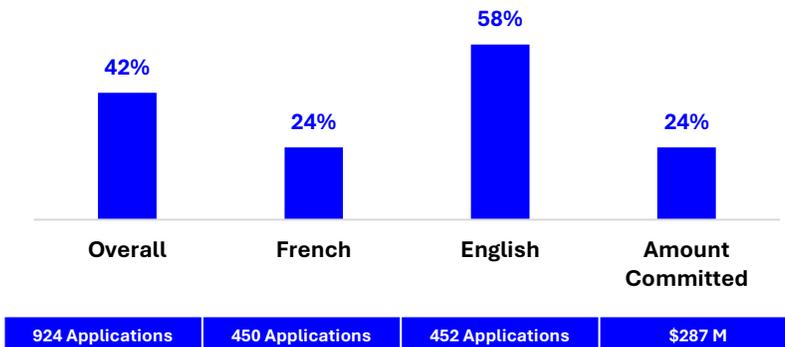

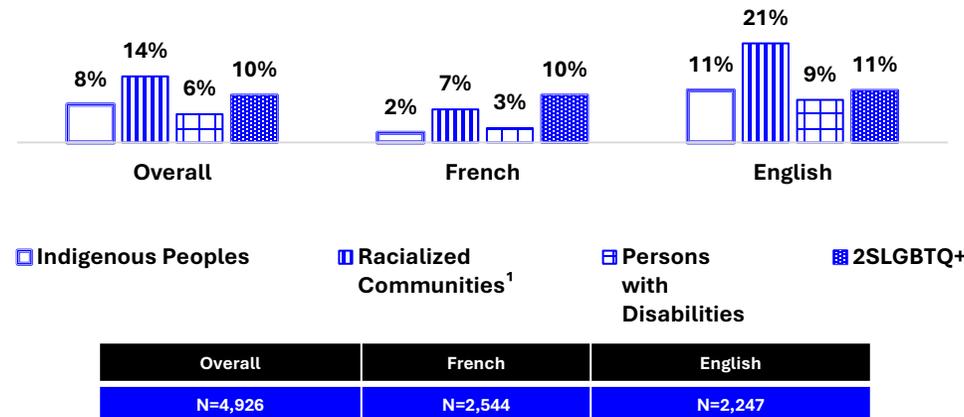

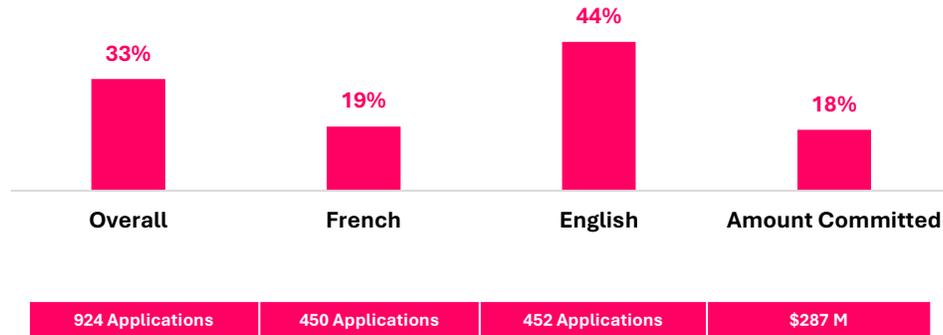

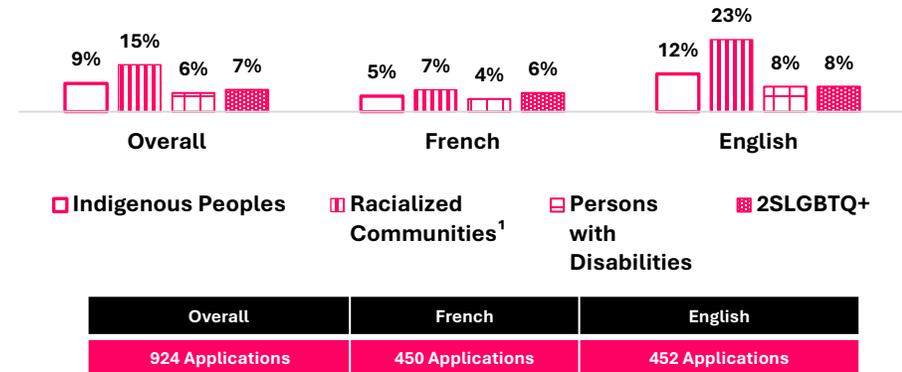

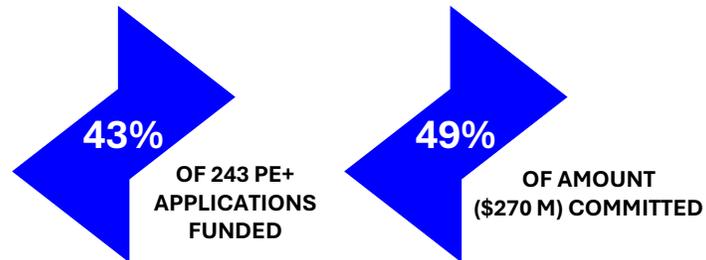

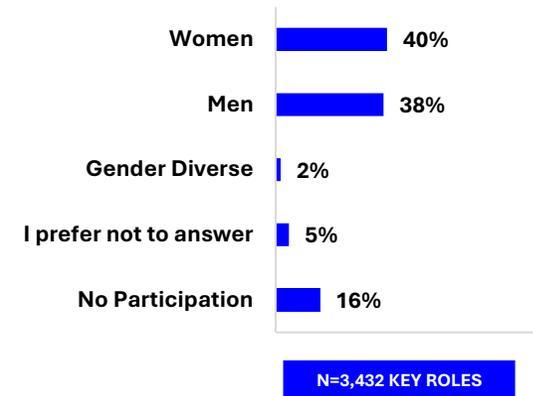

GENDER REPRESENTATION IN KEY ROLES FOR LINEAR PE+ FUNDED APPLICATIONS - 2023-2024

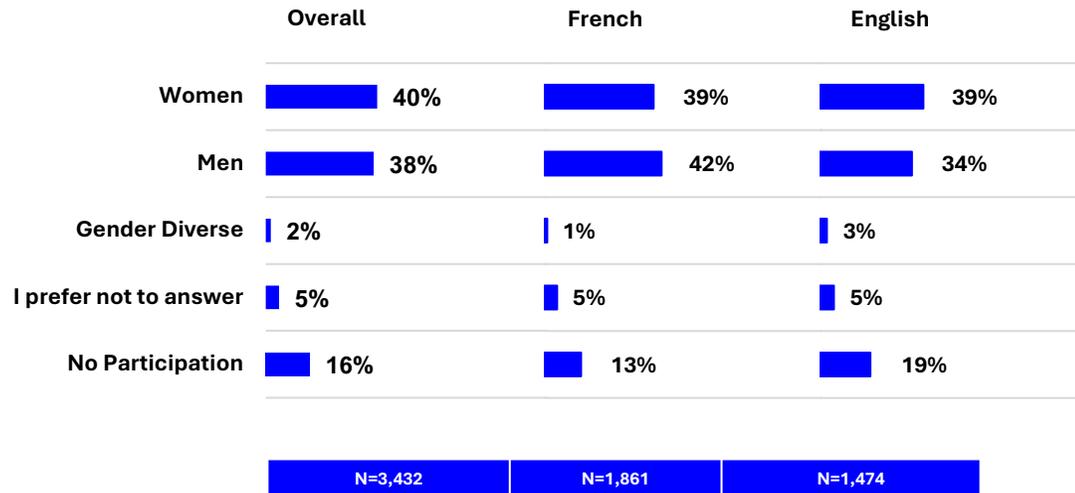

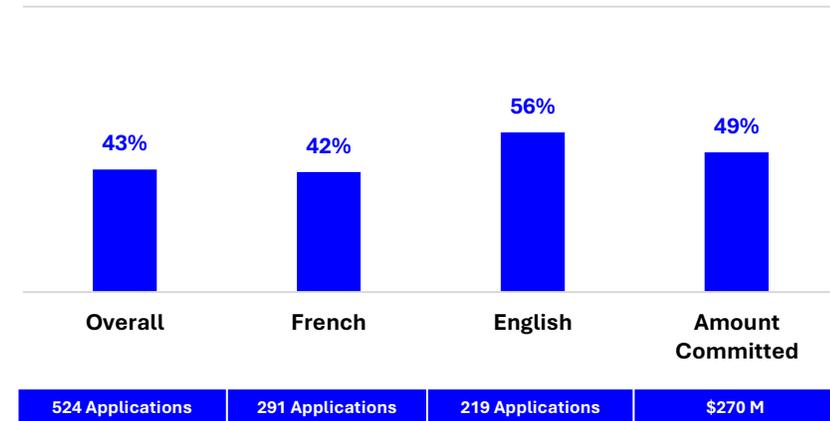

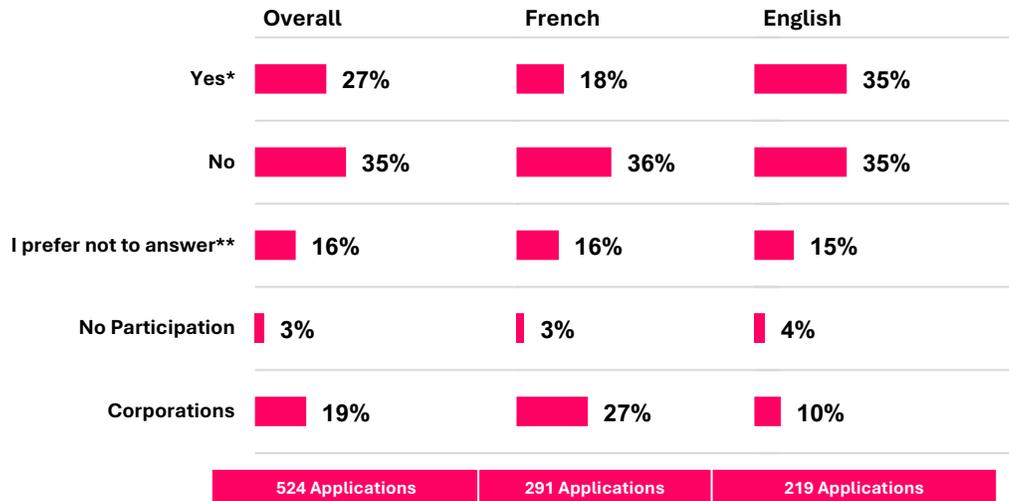

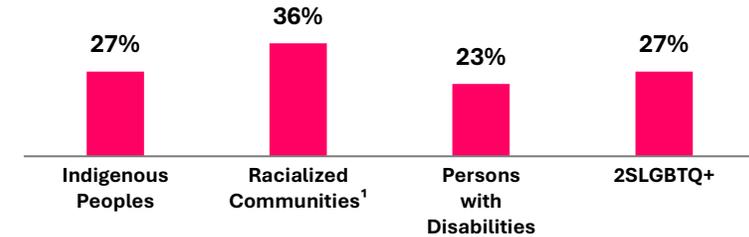

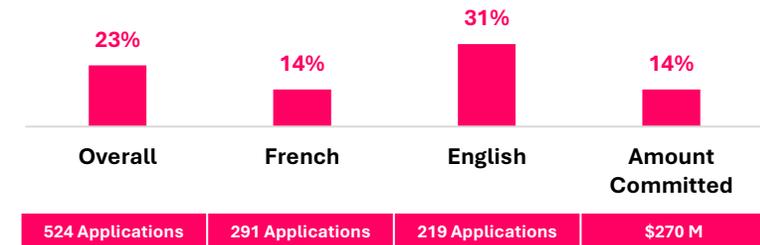

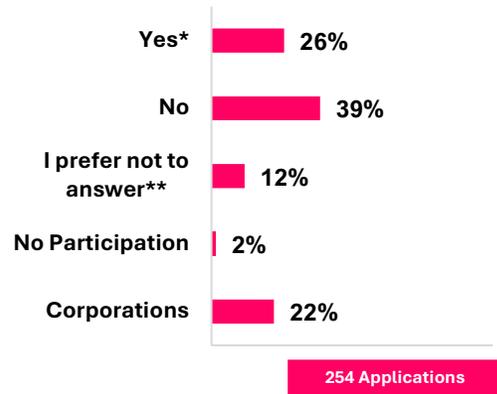

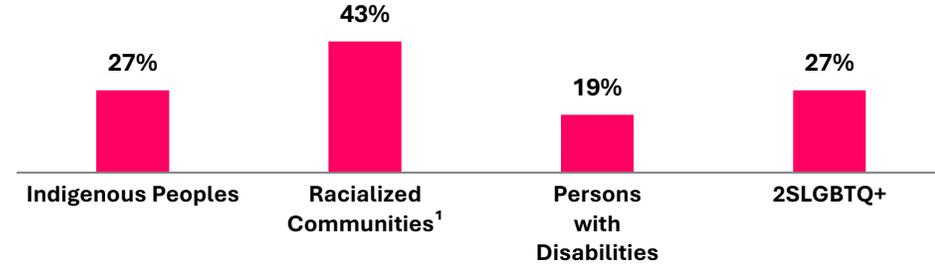

DIVERSE COMMUNITIES REPRESENTATION IN OWNERSHIP FOR DE+ FUNDED APPLICATIONS - 2023-2024



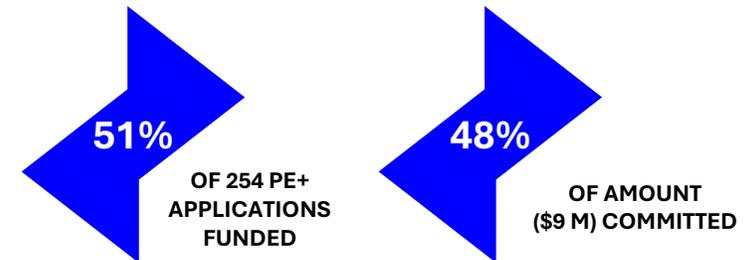

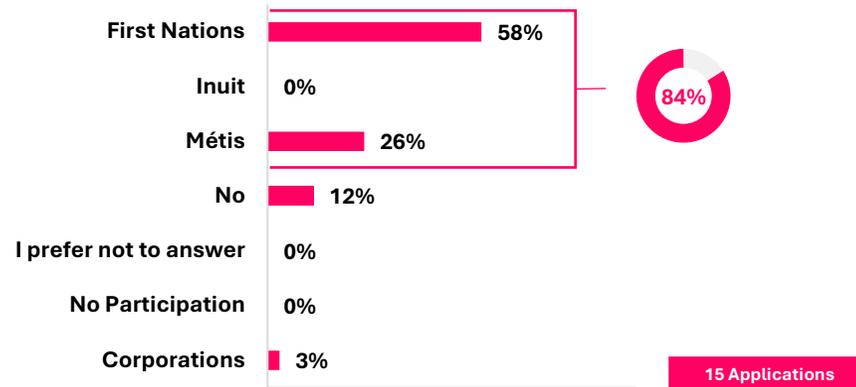

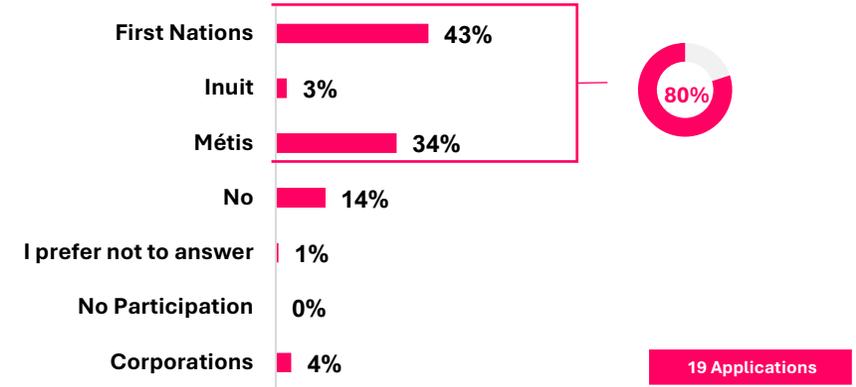

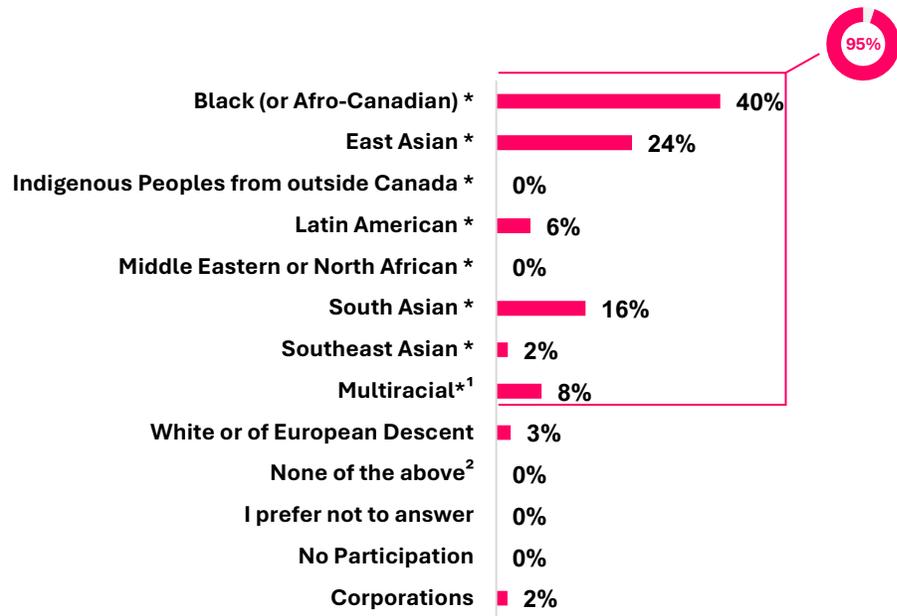

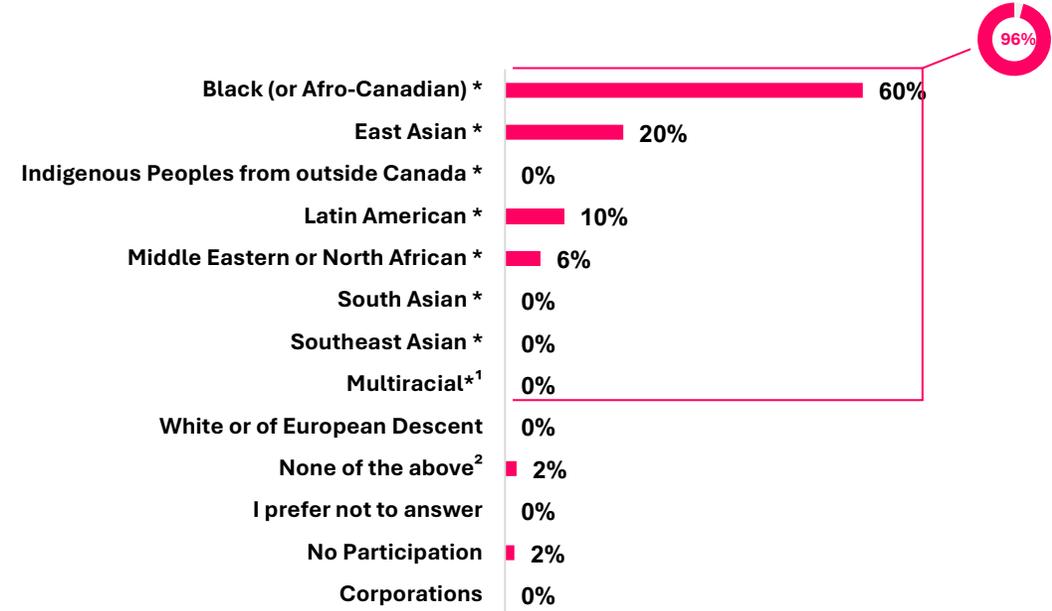

It is important to note that until April 2024, all IDM programs fell under the CMF’s “Experimental Stream” category while linear content fell under the “Convergent Stream”. Since then, all programs have been reorganized on the CMF’s website into three new pillars which reflect stage and funding objectives: Ideation, Creation and Industry.

IDM content includes interactive digital media and application software, such as videogames and immersive experiences (e.g. Virtual Reality and Augmented Reality), as well as web and mobile applications/software with a connection to the Canadian Cultural sector.

In this report, results for “Representation in Interactive Content” are presented in two sections: Overall and Programs:

- **Overall Representation in Interactive Content** reports on the results for all IDM content combined following the PERSONA-ID demographic categories and broken down by Key Roles and content type (Videogames vs other content types).
- **Representation in Interactive Programs** presents the results for the interactive programs highlighting the impact of certain EDIA incentives put in place. Please note that the Innovation and Experimentation Program and the Commercial Projects Program are reported together to ensure a larger sample size.

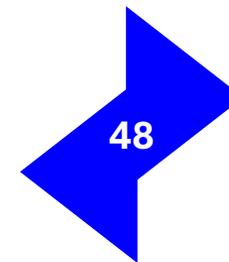

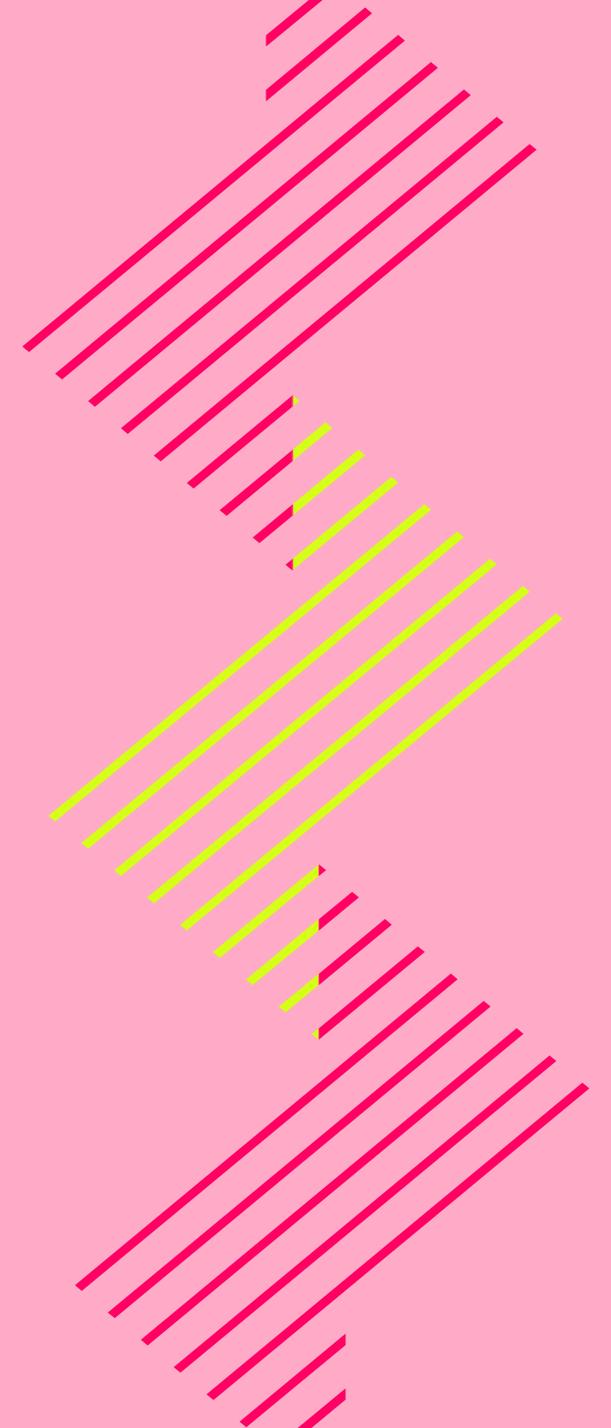

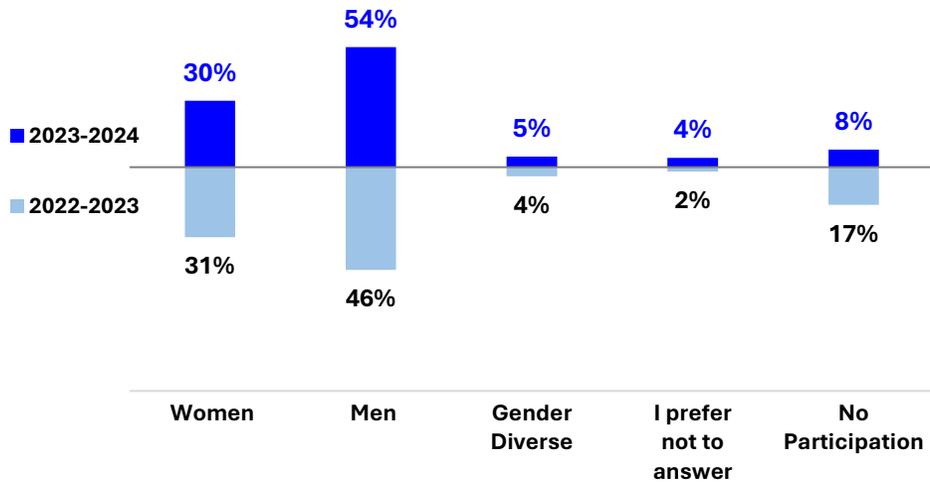

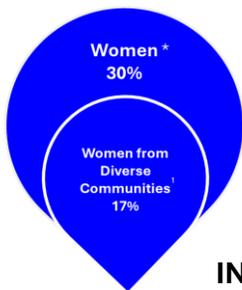

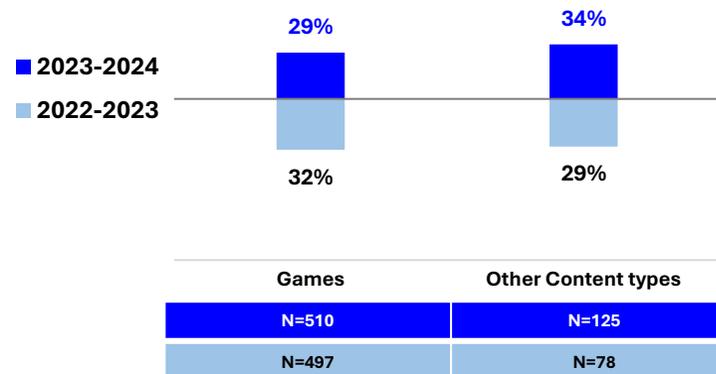

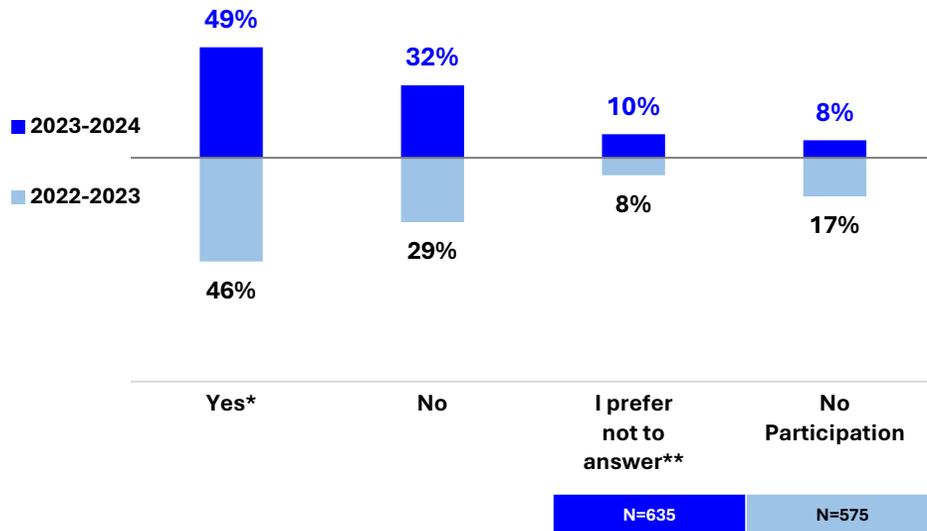

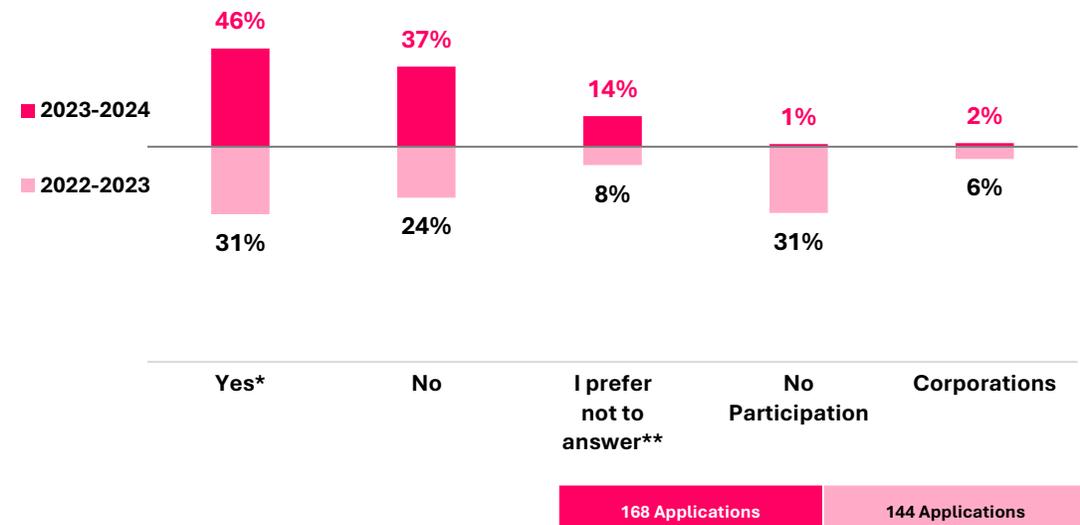

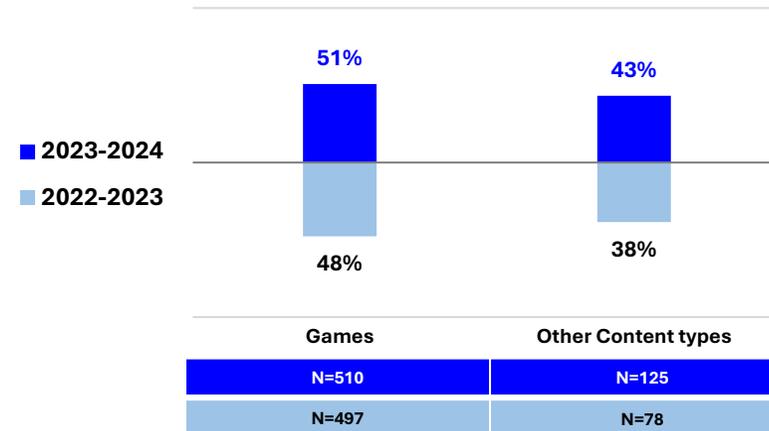

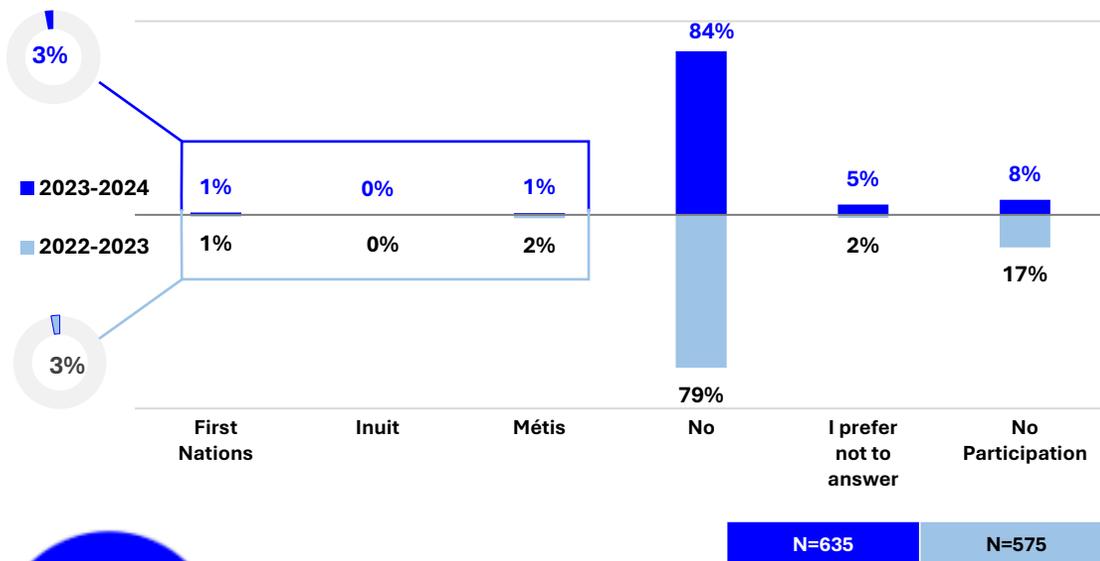

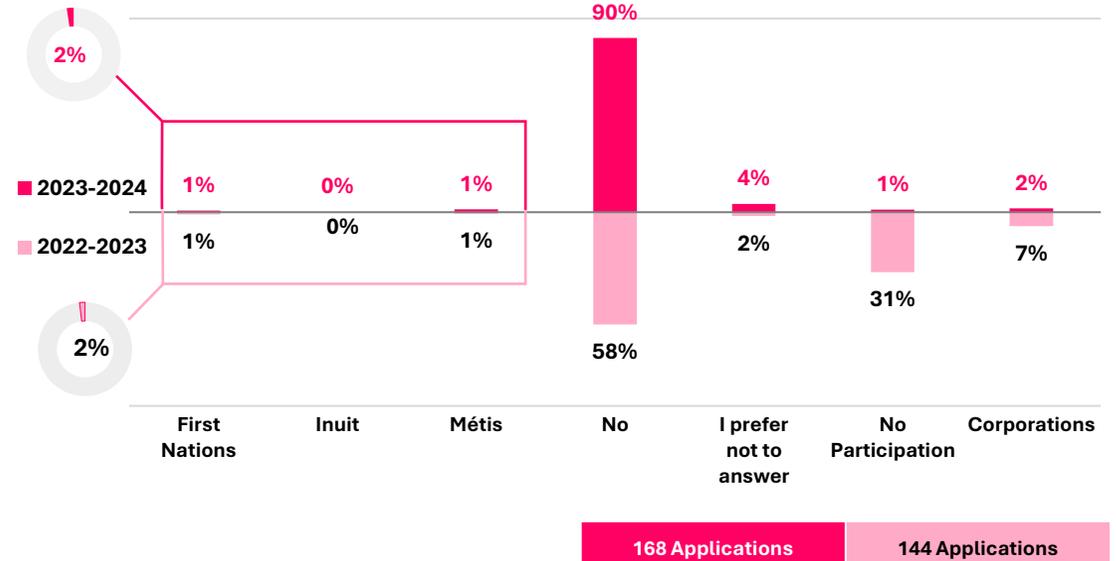

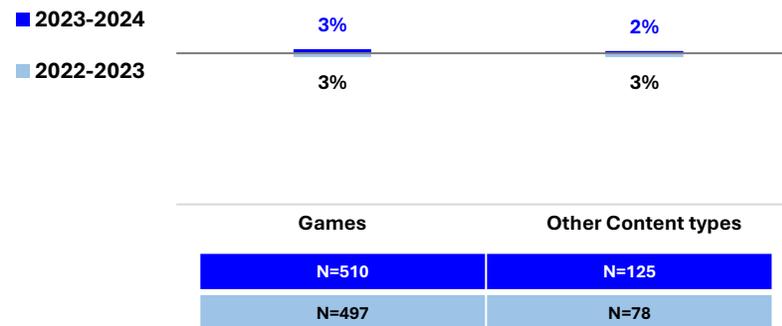

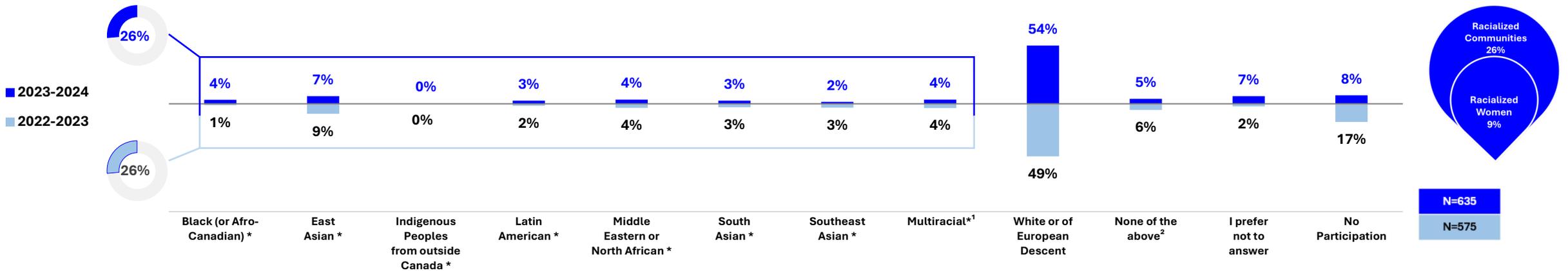

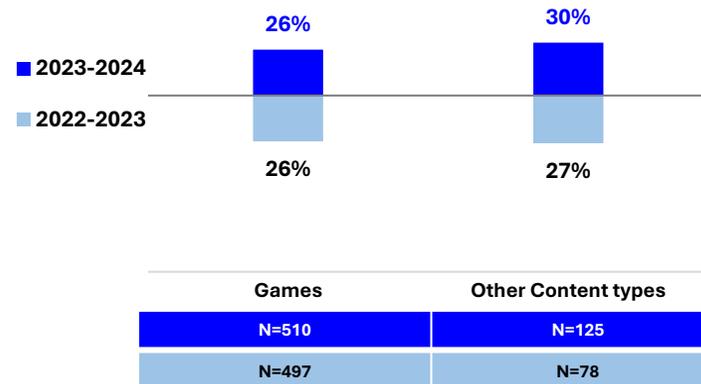

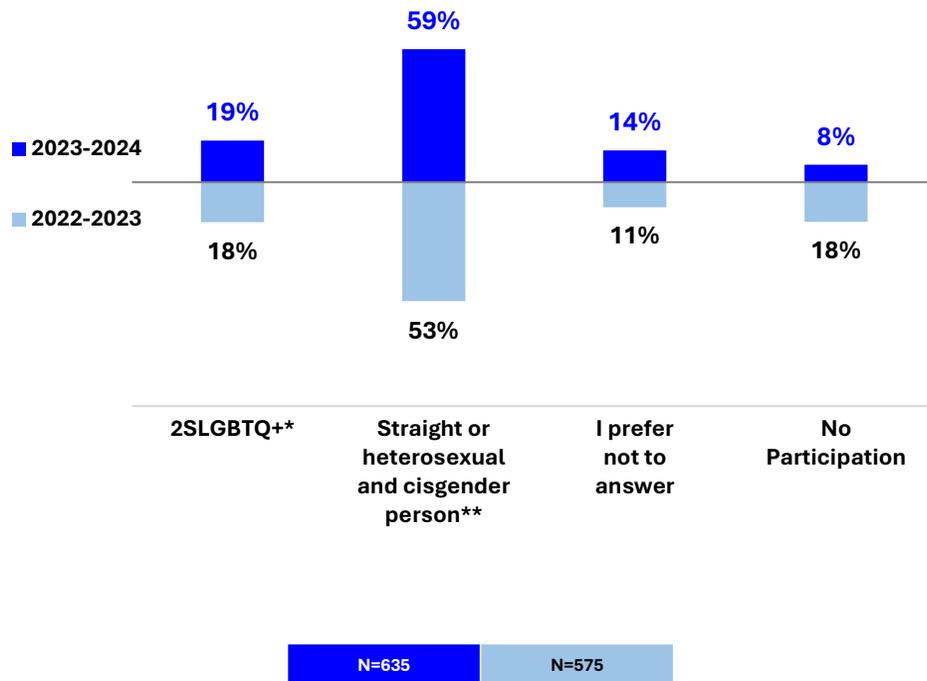

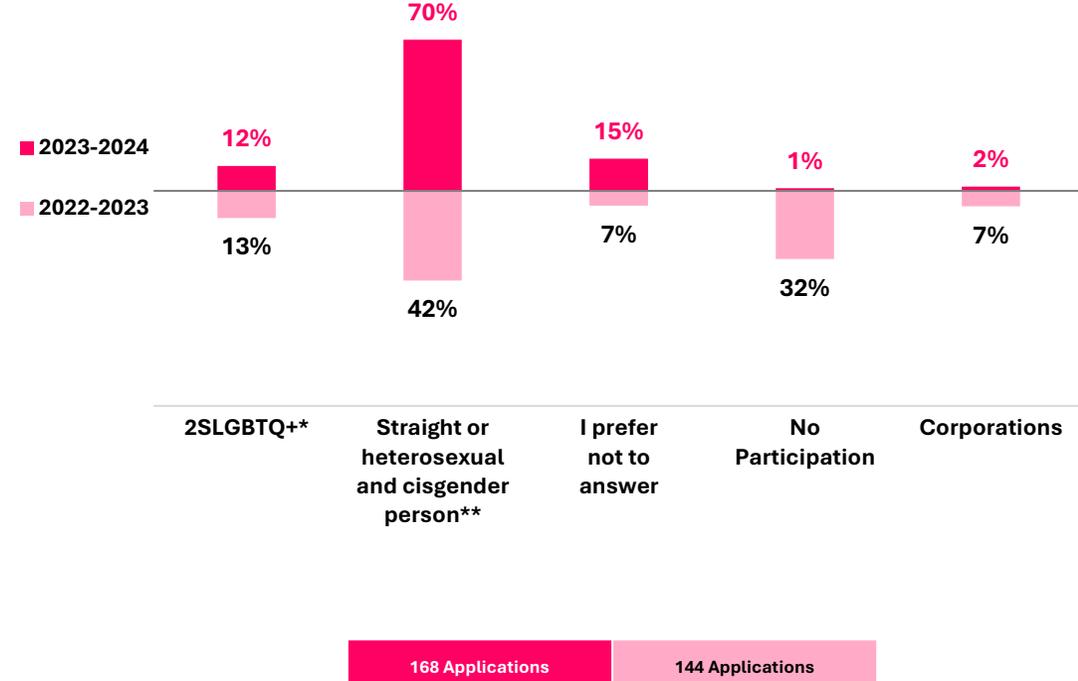

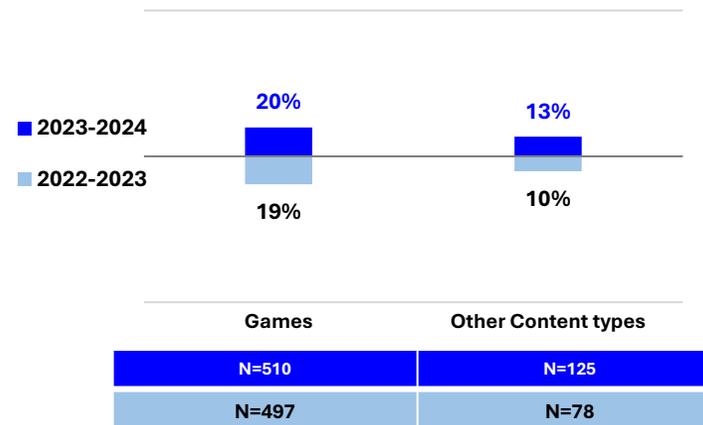

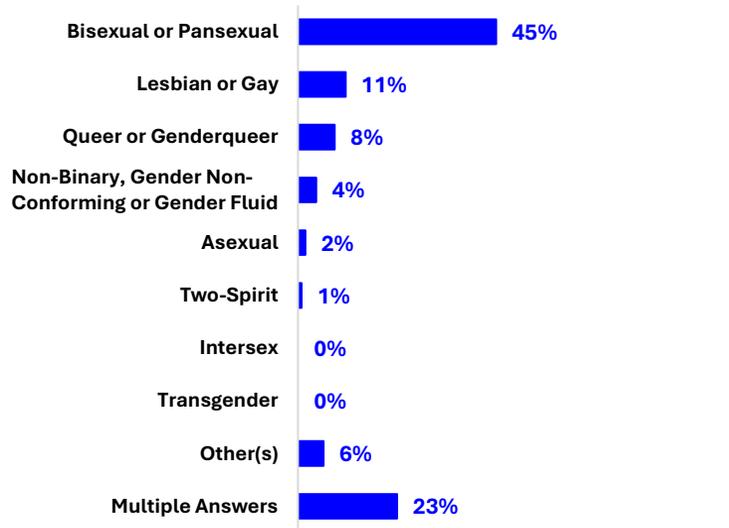

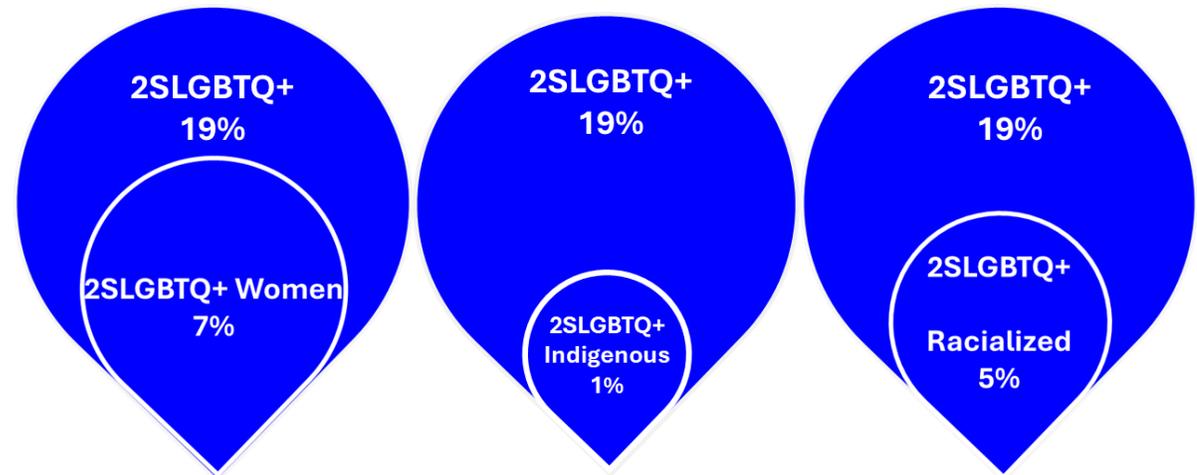

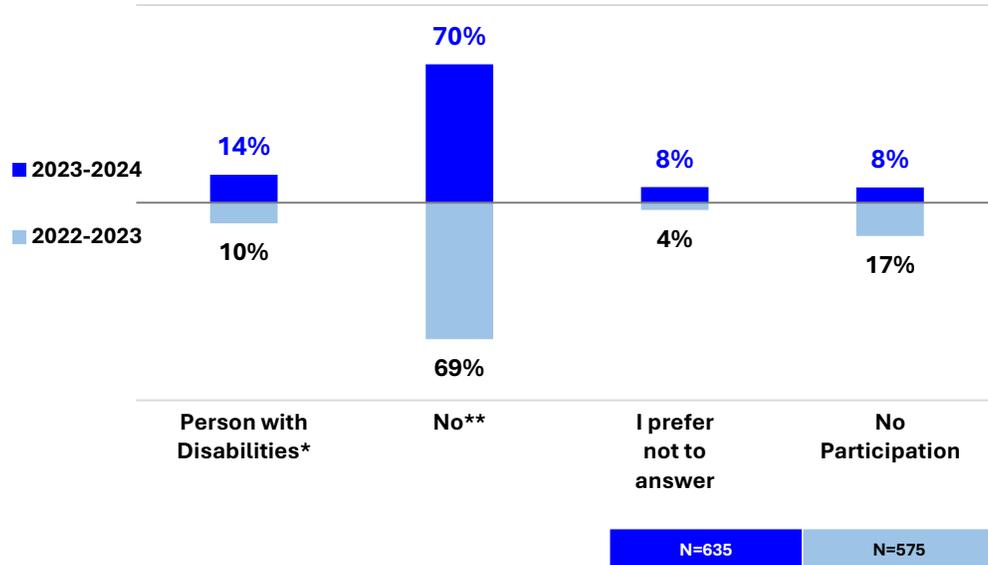

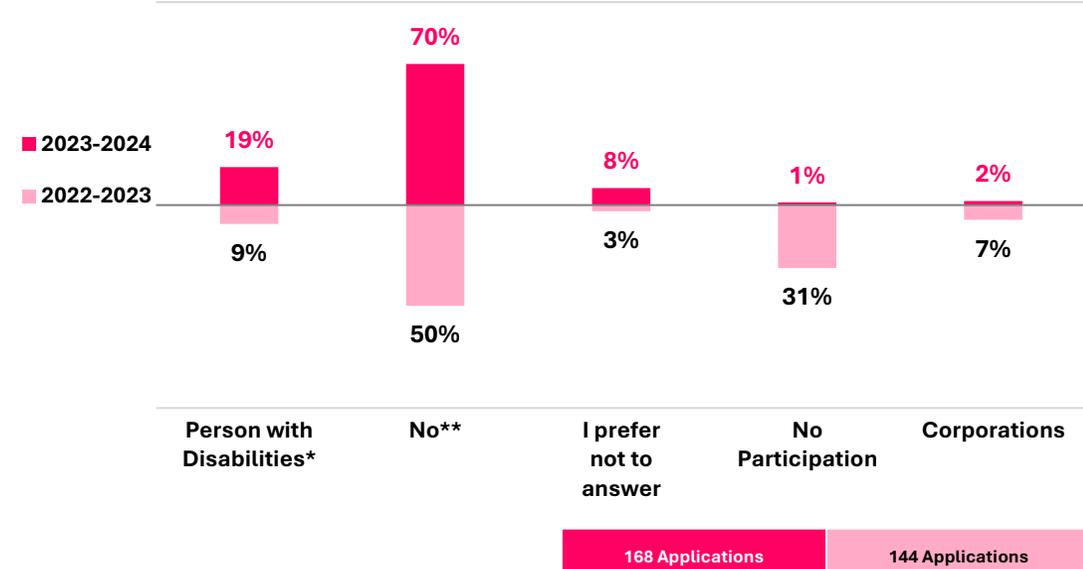

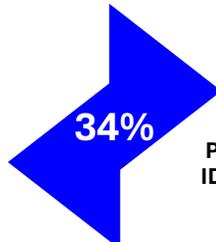

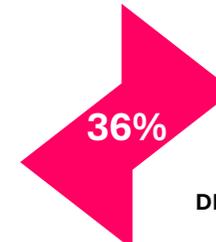
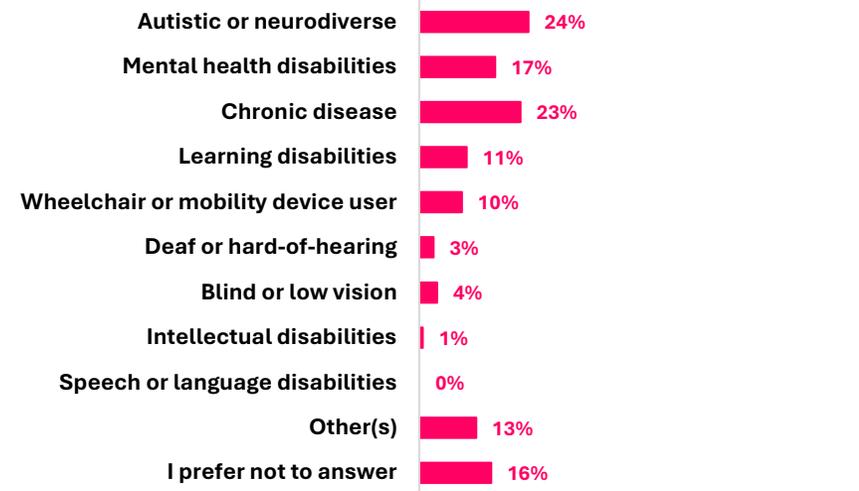

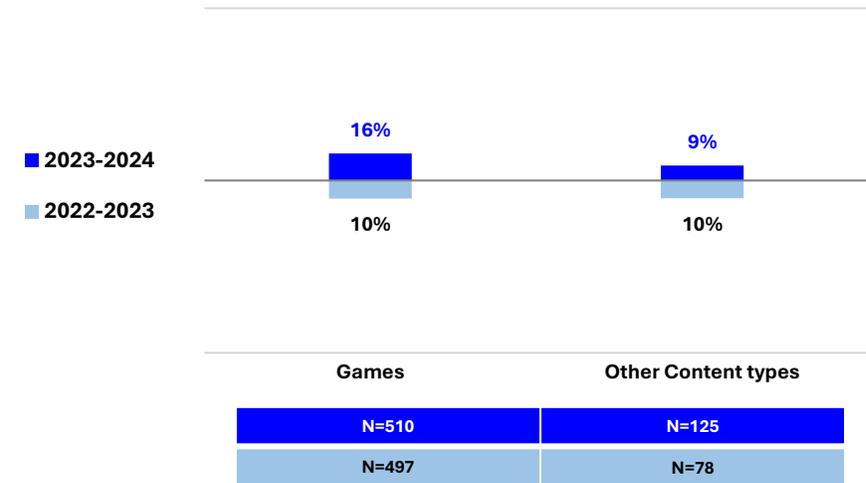

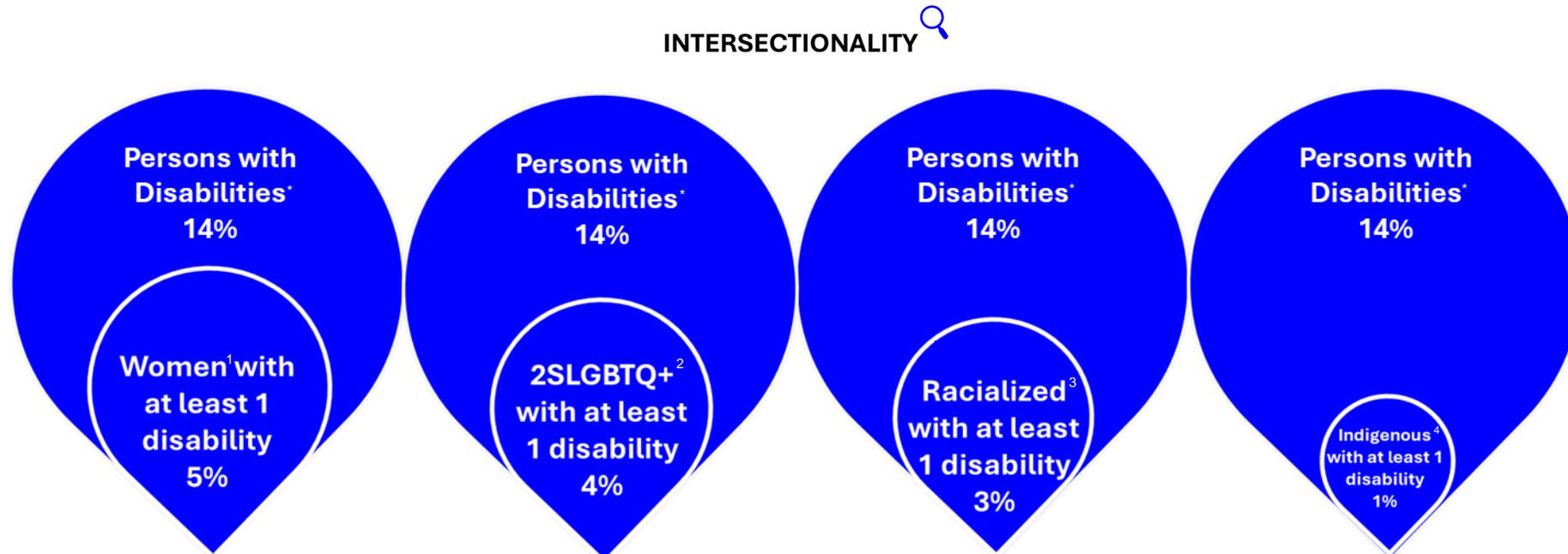

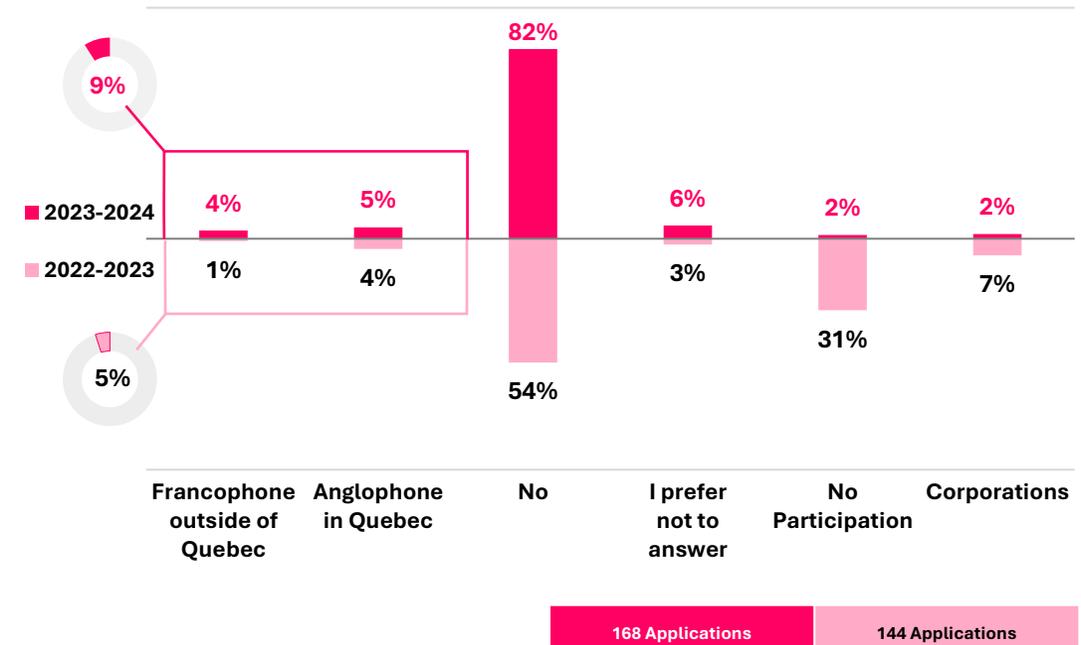

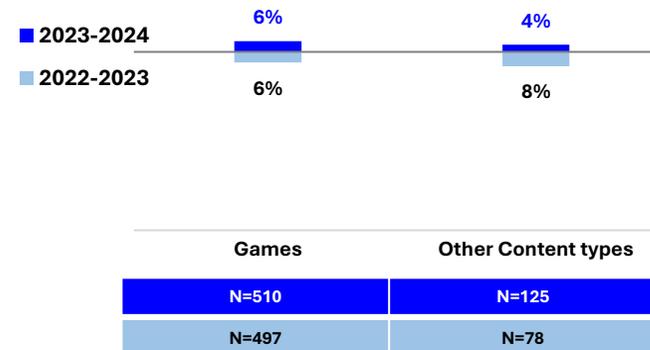

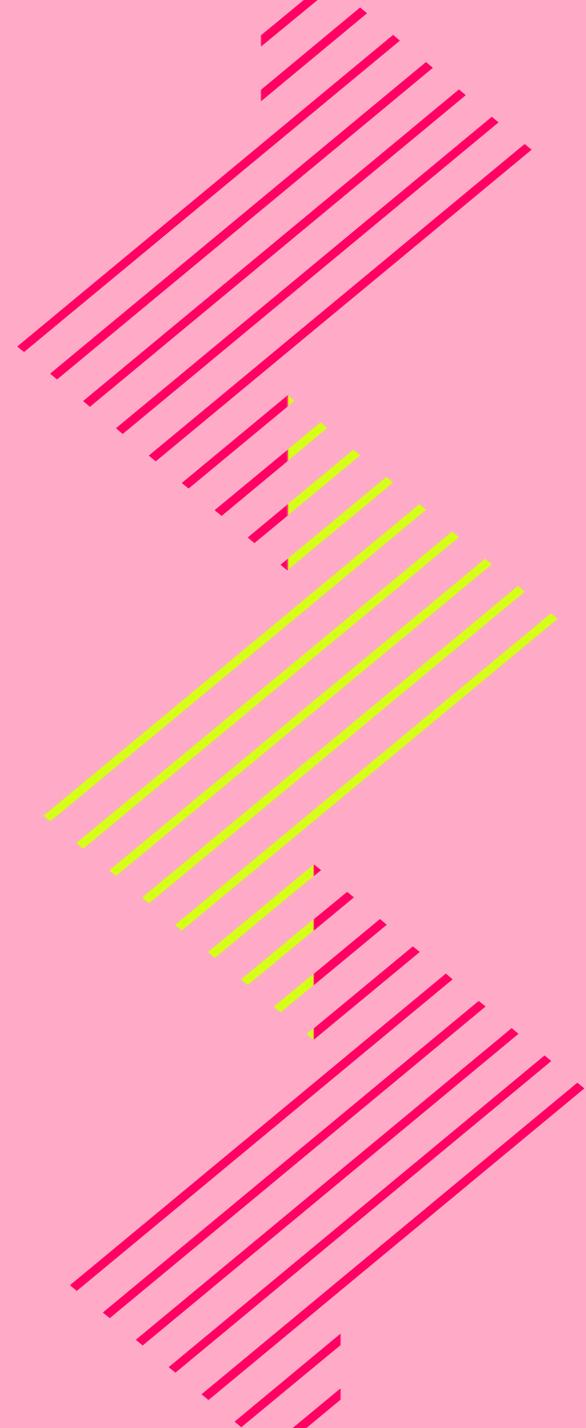

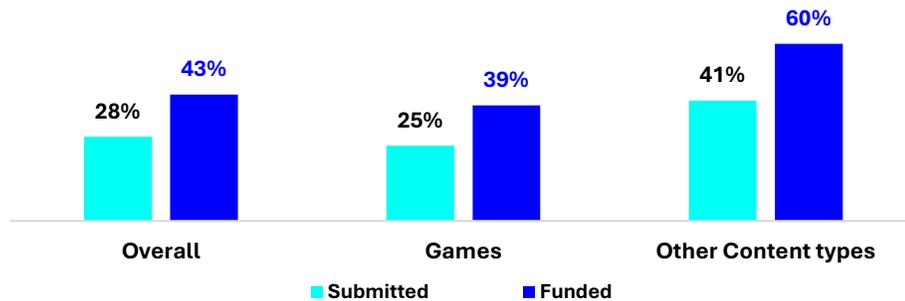

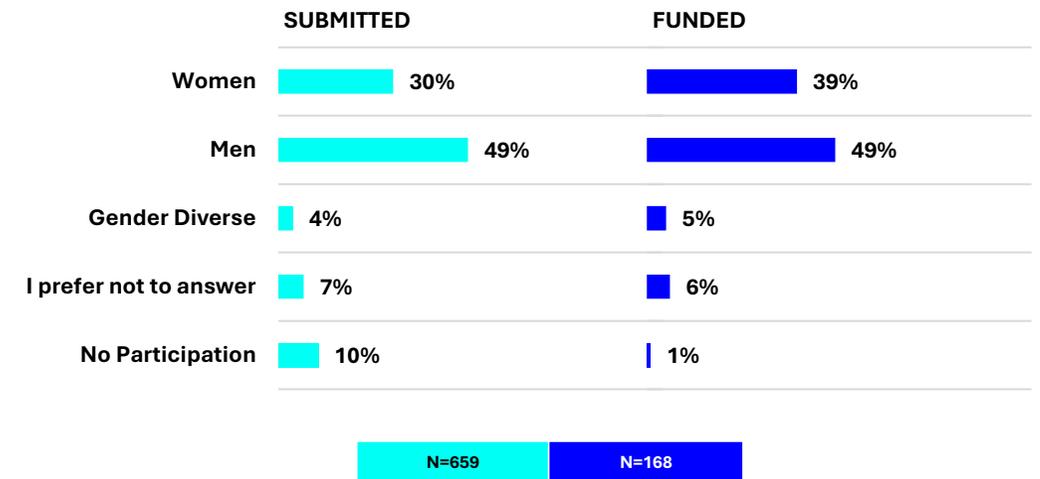

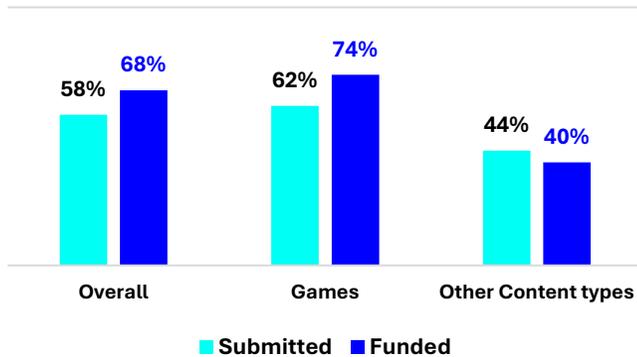

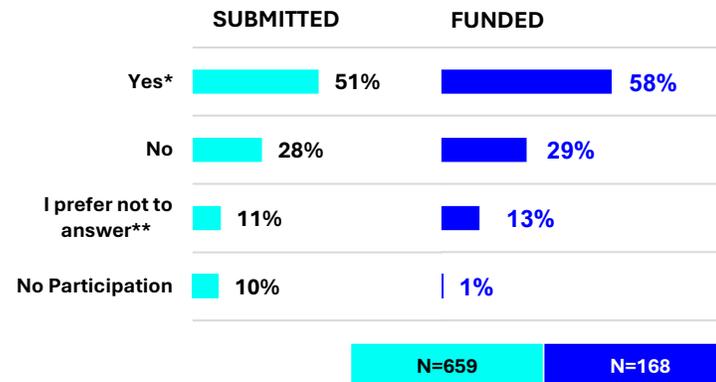

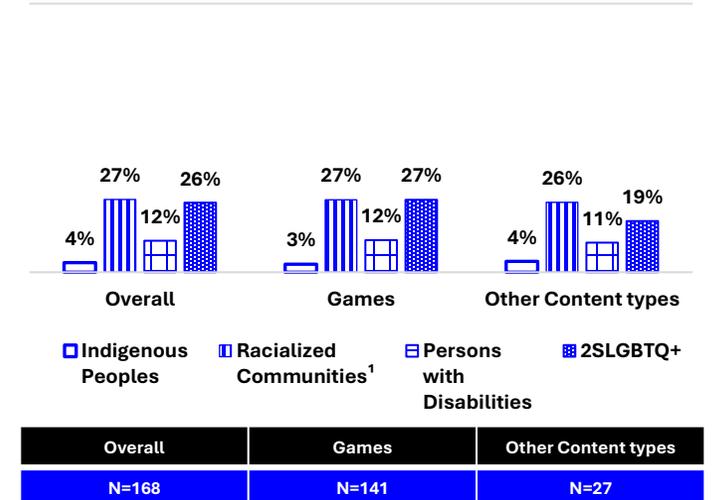

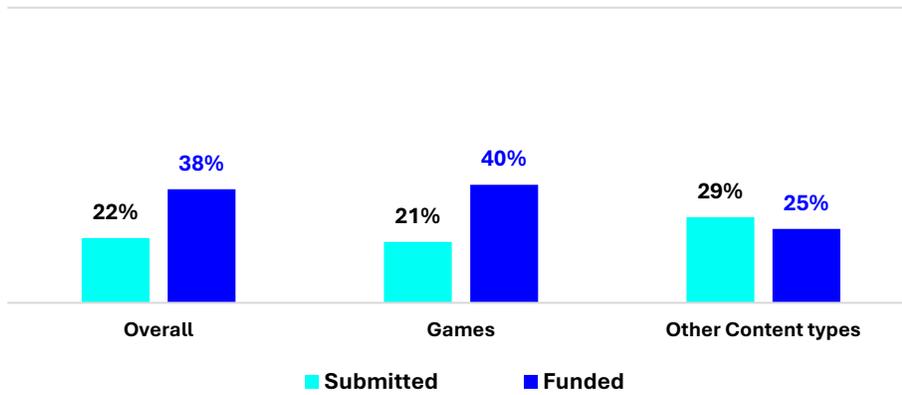

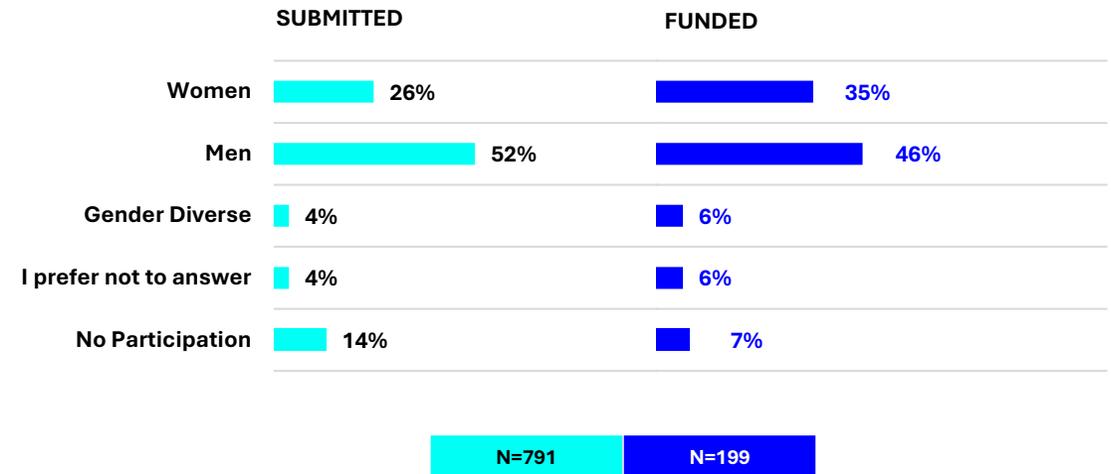

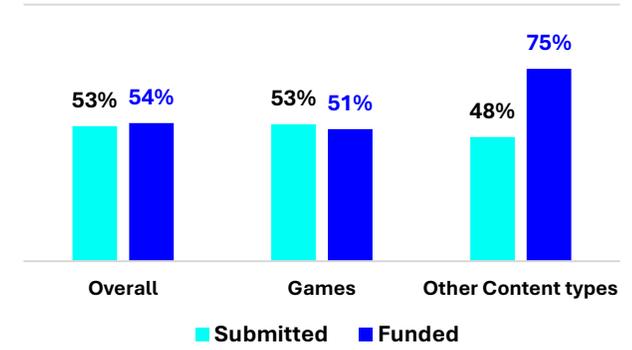

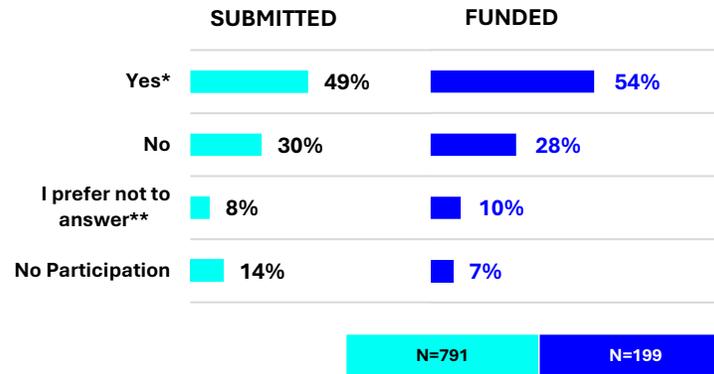

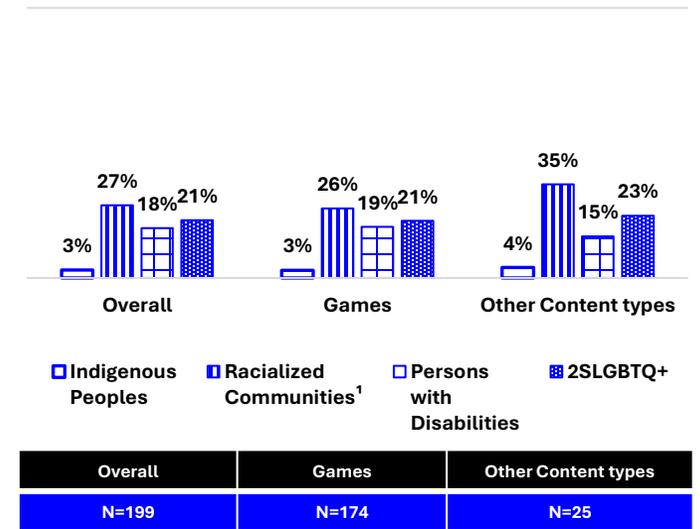

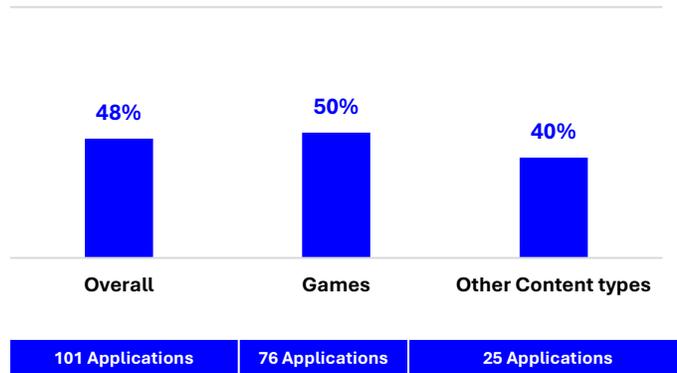

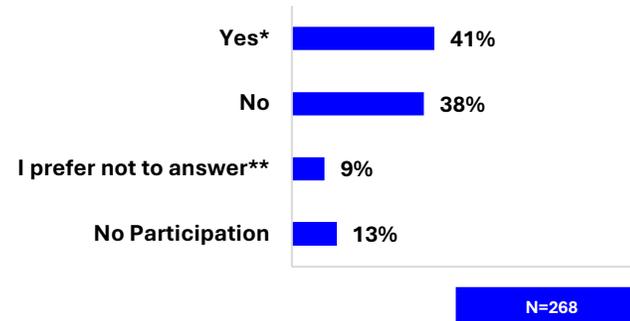
# CONCEPTUALIZATION PROGRAM - KEY ROLES BY DIVERSE COMMUNITIES

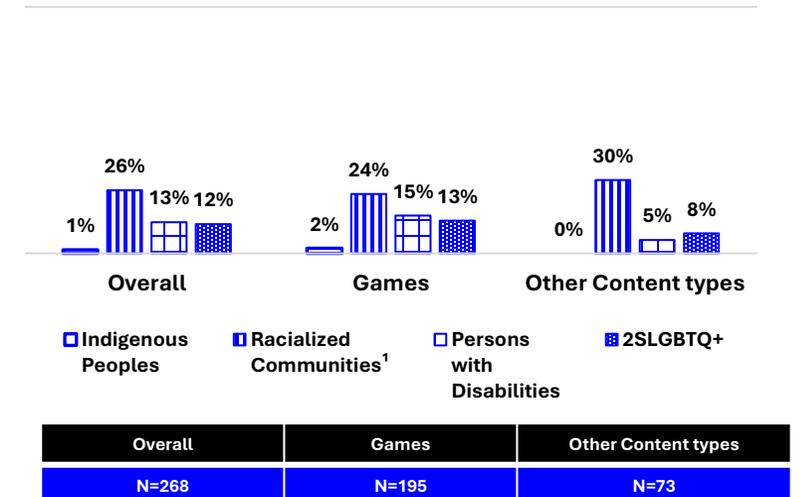

# SECTOR DEVELOPMENT SUPPORT

The Sector Development Support program provides project-based funding to support industry initiatives that demonstrate the potential to positively impact Canada’s audiovisual ecosystem. For this program, priority is given to projects led by, and addressing the needs of Women, Diverse Communities, and Official Language Minority Communities (OLMCs).

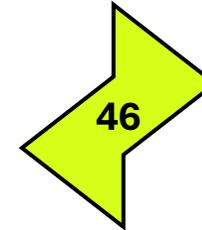
This program supports applications in two main streams:

- **CAPACITY BUILDING** seeks to support projects and initiatives that meaningfully advance opportunities for participants to build skills and capacity that can further their individual or company growth and participation in the industry.
- **MARKET ACCESS** seeks to support projects and initiatives that meaningfully advance opportunities for participants and their projects to realize commercial opportunities and/or finance projects.

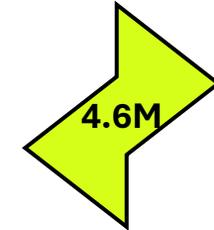
Eligible Applicants are non-profit organizations with a primary mandate in the Canadian screen-based sector.

As part of the application, the organizations are asked to provide the PERSONA-ID numbers of their board members and the project’s key personnel, which include the Executive Director, Project Lead and/or Coordinator among other options.

For the first time, in 2023-2024, the CMF is reporting on the demographic composition of the funded projects in this program.

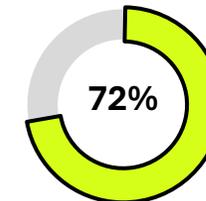


Number of funded projects

PERSONA-ID PARTICIPATION RATE

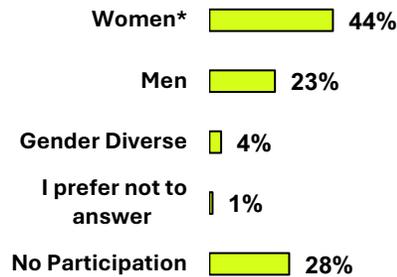

# SECTOR DEVELOPMENT SUPPORT

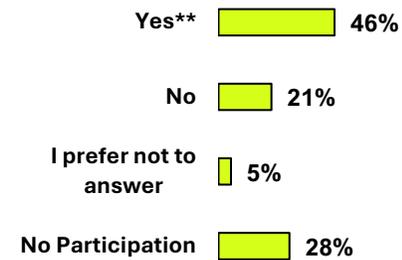
Women represented 44% of all declared board members and key personnel in funded projects; 46% were members of at least one Diverse Community and among them, 30% belonged to a Racialized Community

SECTOR DEVELOPMENT- 2023-2024**



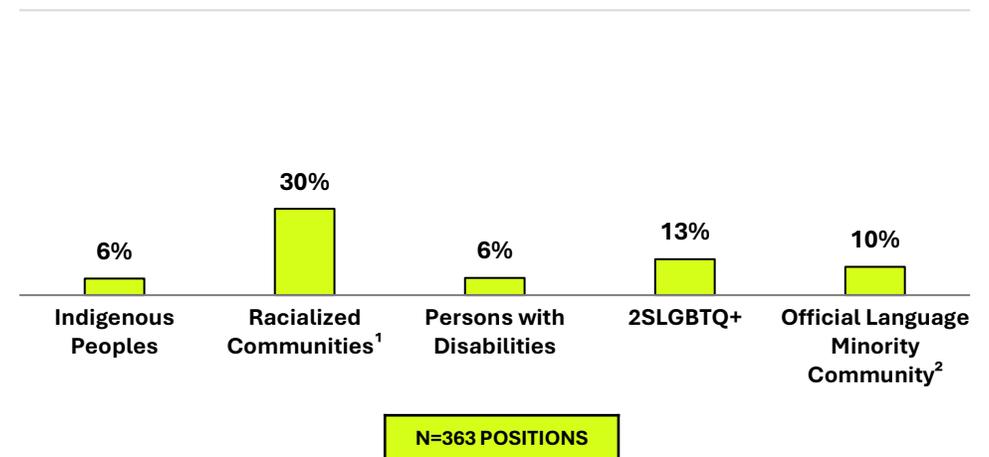
